FIRST AMENDMENT TO NASSAU COUNTY PIGGYBACK AGREEMENT

THIS FIRST AMENDMENT TO NASSAU COUNTY PIGGYBACK AGREEMENT (hereinafter "Amendment") is made by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter the "County"), and GIDDENS SECURITY CORPORATION, a business having its primary business location at 528 South Edgewood Avenue, Jacksonville, FL 32205 (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Armed Security Services for the James Page Facility [CM3666] effective April 25, 2024 (hereinafter "Contract"); and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

- **NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:
- **SECTION 1.** Section 3. Prices, Parties and Additional Terms and Conditions. is amended at Section 3.1 to increase the not to exceed amount to One Hundred Thousand Dollars and 00/100 (\$100,000.00). All other terms and conditions of this Section shall remain the same.
- **SECTION 2.** Section 4. Term of Agreement. is amended at Section 4.1 to provide for the term of the Contract to end on **January 25**, **2025**. All other terms and conditions of this Section shall remain the same.
- **SECTION 3.** In accordance with Section 787.06, Florida Statutes, the Vendor shall provide the County an affidavit, on a form approved by the County, signed by an officer or a representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.
- **SECTION 4.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
