FUNDING AGREEMENT FOR MICAH'S PLACE, INC. FISCAL YEAR 2024-2025

THIS AGREEMENT is entered into by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY**, a political subdivision of the State of Florida, hereinafter referred to as "County", and **MICAH'S PLACE**, **INC.**, P.O. Box 16287, Fernandina Beach, Florida, 32035, hereinafter referred to as "Micah's".

WHEREAS, Micah's provides prevention and intervention services for victims of domestic violence within Nassau County, Florida; and

WHEREAS, the County recognizes that it is in the best interest of the citizens of Nassau County, Florida that Micah's continues to work with the citizens to provide prevention and intervention services for victims of domestic violence within Nassau County, Florida; and

WHEREAS, the County is desirous of entering into a funding agreement with Micah's in order to fund said services.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

SECTION 1. RECITALS.

1.1 The above recitals are true and correct and are incorporated herein, in their entirety, by this reference.

SECTION 2. FUNDING.

2.1 For the services outlined in this Agreement, the County shall pay Micah's the sum of Fifty Thousand Dollars and 00/100 (\$50,000.00), which shall be paid in quarterly installments, during the months of December, February, May and August

of the fiscal year. Appropriations necessary for the funding of this Agreement beyond FY 2024/2025 shall be subject to the budget and appropriation by the County during the regular budget process. Said services to include, but not be limited to, the following:

- a. Continuing the present level of services, as of the date of this Agreement, provided for the citizens of Nassau County, Florida.
- 2.2 In performing its obligation under this Agreement, Micah's shall be at all times acting in the capacity of an independent contractor and not as an officer, employee or agent of the County.
- 2.3. Micah's shall submit simultaneously to the County Manager and the Clerk an annual accounting acceptable to the Clerk on or before December 31st of each fiscal year in which Micah's received funding from the County. Additionally, Micah's shall make its books available for inspection by a designee of the County upon reasonable notice. Failure of Micah's to provide the annual accounting record by the time specified shall result in the revocation of granting of further funds and reimbursement of funds distributed during the year for which no report was submitted.
- 2.4 Failure of Micah's to satisfactorily comply with the terms of this Agreement may result in a cessation of payment, pursuant to the terms of this Agreement.

SECTION 3. TERM OF AGREEMENT AND OPTION TO AMEND.

3.1 The term of this Agreement shall commence on October 1, 2024 and terminate on September 30, 2025, unless terminated by either party thirty (30) days

written notice to the other party, subject to completion of all previous and outstanding billings.

3.2 This Agreement may be amended only in writing by mutual consent of the parties.

SECTION 4. THE AMERICANS WITH DISABILITIES ACT, FLORIDA PUBLIC RECORDS LAW.

- 4.1 All facilities, programs and services should be compliant with the Florida Accessibility Code and the Federal Americans with Disabilities Act (ADA). Failure to provide facilities, programs, or services that are compliant with both the Florida Accessibility Code and the Federal Americans with Disabilities Act (ADA) shall be considered a breach of the Agreement and may result in termination of this Agreement.
- The County is a public agency subject to Chapter 119, Florida Statutes. **IF** 4.2 MICAH'S HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO **MICAH'S DUTY** TO **PROVIDE PUBLIC** RECORDS RELATING TO **THIS** AGREEMENT, CONTACT THE CUSTODIAN OF PUBLIC RECORDS AT (904) 530-6090, RECORDS@NASSAUCOUNTYFL.COM, 96135 NASSAU PLACE, SUITE 6, YULEE, FLORIDA 32097. Under this Agreement, to the extent that Micah's is providing goods and/or services to the County, and pursuant to Section 119.0701, Florida Statutes, Micah's shall:

 Keep and maintain public records required by the County to provide goods and/or services.

- b. Upon request from the County's custodian of public records, provide the County with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in this chapter or as otherwise provided by law.
- c. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the Agreement term and following completion of the Agreement if Micah's does not transfer the records to the County.
- d. Upon completion of the Agreement, transfer, at no cost, to the County all public records in possession of Micah's or keep and maintain public records required by the County to perform the service. If Micah's transfers all public records to the County upon completion of the Agreement, Micah's shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If Micah's keeps and maintains public records upon completion of the Agreement, Micah's shall meet all applicable requirements for retaining public records. All records stored electronically shall be provided to the County, upon request from the County's custodian of public records, in a format that is compatible with the information technology systems of the County.
- 4.3 A request to inspect or copy public records relating to the County's agreement for goods and/or services shall be made directly to the County. If the County does not possess the requested records, the County shall immediately notify

Micah's of the request, and Micah's shall provide the records to the public agency or allow the records to be inspected or copied within a reasonable time.

- 4.4 If Micah's does not comply with the County's request for records, the County shall enforce the Agreement provisions in accordance with the Agreement.
- 4.5 If Micah's fails to provide the public records to the County within a reasonable time, Micah's may be subject to penalties under Section 119.10, Florida Statutes.
- 4.6 If a civil action is filed against Micah's to compel production of public records relating to the Agreement, the Court shall assess and award against Micah's the reasonable costs of enforcement, including reasonable attorney fees if:
- (a) The Court determines that Micah's unlawfully refused to comply with the public records request within a reasonable time; and
- (b) At least eight (8) business days before filing the action, the plaintiff provided written notice of the public records request, including a statement that Micah's has not complied with the request, to the County and to Micah's.
- 4.7 A notice complies with this Section, if it is sent to the County's custodian of public records and to Micah's at Micah's address listed on its Agreement with the County or to Micah's registered agent. Such notices shall be sent to the address listed above for each party.
- 4.8 If Micah's complies with a public records request within eight (8) business days after the notice is sent, Micah's is not liable for the reasonable costs of enforcement.

SECTION 5. TERMINATION.

5.1 If Micah's fails to perform any of its obligations under this Agreement,

and if such default remains uncured for more than fifteen (15) days after written

notice was provided by the County, then the County may, without prejudice to

any right or remedy the County may have, terminate this Agreement and cessation

of payment.

5.2 The County reserves the right to terminate this Agreement in whole or part

by giving Micah's written notice at least thirty (30) days prior to the effective date

of termination.

SECTION 6. GOVERNING LAW, VENUE AND COMPLIANCE WITH

LAWS.

6.1 This Agreement shall be deemed to have been executed and entered into

within the State of Florida and any dispute arising hereunder, shall be governed,

interpreted and construed according to the laws of the State of Florida, the

Ordinances of Nassau County, and any applicable federal statutes, rules and

regulations. Any and all litigation arising under this Agreement shall be brought

in Nassau County, Florida, and any trial shall be non-jury. Any mediation,

pursuant to litigation, shall occur in Nassau County, Florida.

6.2 Micah's shall comply with any applicable regulatory requirements

including federal, state, and local laws, rules, regulations codes, orders, criteria

and standards.

SECTION 7. NO ASSIGNMENT.

7.1 Micah's shall not assign, sublet, convey or transfer its interest in this
