

FIRST AMENDMENT TO CONTRACT FOR KITCHEN AND REFRIGERATION PREVENTATIVE MAINTENANCE AND REPAIR SERVICES

THIS FIRST AMENDMENT TO THE CONTRACT FOR KITCHEN AND REFRIGERATION PREVENTATIVE MAINTENANCE AND REPAIR SERVICES (hereinafter "Amendment") is made by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter the "County"), and WHALEY FOODSERVICE, LLC, a business having its primary business location at PO Box 615, Lexington, South Carolina 29071-0615, (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for kitchen and refrigeration preventative maintenance and repair service dated October 6, 2023 (hereinafter "Contract"); and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

NOW, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

- **SECTION 1.** Section 4 of the Contract is hereby amended to increase the Vendor's compensation by an amount not to exceed Fifteen Thousand Dollars and 00/100 (\$15,000.00) for a total compensation amount not to exceed Thirty Thousand Dollars and 00/100 (\$30,000.00).
- **SECTION 2.** Section 6 of the Contract is hereby amended to renew the term of the Contract for an additional one (1) year and the Contract shall now terminate on September 30, 2025.
- **SECTION 3.** Pursuant to Section 787.06, Florida Statutes, Vendor shall provide the County on a form approved by the County an affidavit signed by an officer or a representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Stat
- **SECTION 4.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.

From time to time, County of Nassau (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you.
