FIRST AMENDMENT TO BROKER/AGENT AGREEMENT FOR NASSAU COUNTY, FLORIDA

THIS FIRST AMENDMENT TO THE BROKER/AGENT AGREEMENT (hereinafter "Amendment") is made by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter the "County"), and MFB FINANCIAL, INC., dba THE BAILEY GROUP, a business having its primary business location at 1200 Plantation Island Dr., Suite 210, Saint Augustine, Florida 32080 (hereinafter the "Broker/Agent").

WITNESSETH:

WHEREAS, the Parties previously entered into a Broker/Agent Agreement dated November 23, 2020 (hereinafter "Agreement"); and

WHEREAS, the Bailey Group has provided and shall continue to render services from January 1, 2024 through December 31, 2024 under the current terms and conditions of the Agreement which provides for an annual fee of Seventy-Two Thousand Dollars (\$72,000.00); and

WHEREAS, the Agreement further allows for an extension of the term of the Agreement; and

WHEREAS, the parties have mutually agreed to extend the term of the Agreement and to further modify the Agreement as contained herein; and

WHEREAS, the Parties now desire to amend the Agreement terms and conditions subject to the provisions contained herein.

NOW, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Agreement as follows:

SECTION 1. Article V. Term. of the Agreement is hereby amended to extend the term of the Agreement for an additional one (1) year and the Agreement shall now terminate on December 31, 2025.

SECTION 2. Article XIII. Miscellaneous at Section 13.1 of the Agreement is hereby amended to remove the reference to Michael S. Mullin as the County Attorney and the contact information provided therewith and is amended to read as follows:

SECTION 3. Article XIII. Miscellaneous is further amended to add a new Section 13.6 as follows:

NASSAU COUNTY

13.6 Human Trafficking Affidavit.

In accordance with Section 787.06, Florida Statutes, the Broker/Agent shall provide the County with an affidavit, on a form approved by the County, signed by an officer or a representative of the Broker/Agent under penalty of perjury attesting that the Broker/Agent does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.

SECTION 4. All other terms and conditions of the Agreement not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
