SECOND AMENDMENT TO CONTRACT FOR PAVEMENT MARKINGS SERVICES

THIS SECOND AMENDMENT TO THE CONTRACT FOR PAVEMENT MARKINGS SERVICES (hereinafter "Amendment") is made by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter the "County"), and TRP CONSTRUCTION GROUP, LLC, a business having its primary business location at 2411 Minnis Drive, Fort Worth, Texas 76117 (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Pavement Markings Services dated February 12, 2024 (hereinafter "Contract") and a First Amendment on June 25, 2024; and

WHEREAS, the Contract provided for an initial performance period beginning February 12, 2024 and terminating on September 30, 2024 with the option to extend the performance period for two (2) additional one (1) year periods upon mutual agreement between the Parties; and

WHEREAS, the Parties failed to formally amend the Contract to extend the term beyond September 30, 2024, but the Parties did continue to perform their contractual duties and responsibilities under the Contract, and the Parties agree by this performance there was an implied extension of the term of the Contract; and

WHEREAS, the Parties now desire to formally amend the Contract to memorialize their agreement and to amend its terms and conditions as set forth herein.

NOW, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

- **SECTION 1.** Section 4.1 of the Contract is hereby amended to increase the compensation amount by Three Hundred Thousand Dollars and 00/100 (\$300,000.00) for the goods/services to be provided during the renewal period for a total compensation amount of Six Hundred Twenty Thousand, Nine Hundred Five Dollars and 21/100 (\$620,905.21).
- **SECTION 2.** Section 6.1 of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on September 30, 2025.
- **SECTION 3.** Upon execution, renewal or extension of this Contract, the Vendor shall provide the County on a form approved by the County an affidavit signed by an officer or a representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.
- **SECTION 4.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
