**FIRST AMENDMENT TO CONTRACT FOR DISPOSAL OF COUNTY GENERATED
YARD/LAND CLEARING WASTE AND CONSTRUCTION AND DEMOLITION
DEBRIS SERVICES**

This First Amendment to Contract for Disposal of County Generated Yard/Land Clearing Waste and Construction and Demolition Debris Services (hereinafter “Amendment”) is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the “County”), and Sand Hill Recycling, LLC, a business having its primary business location at 153326 County Road 108, Yulee, FL 32097 (hereinafter the “Vendor”).

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Disposal of County Generated Yard/Land Clearing Waste and Construction and Demolition Debris Services dated April 5, 2023 (hereinafter “Contract”); and

WHEREAS, the Contract provided for an initial performance period beginning April 5, 2023, and terminating on September 30, 2025; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 1 of the Contract is hereby amended to increase the compensation amount for the goods/services to be provided under the Contract due to additional generated yard/land clearing waste and construction & demolition debris by the end of the County’s Fiscal Year 2024/2025. The Contract increase will be in the amount of Twenty-Five Thousand Dollars and 00/100 (\$25,000) and the County shall now compensate the Vendor in an amount not to exceed Seventy Thousand Dollars and 00/100 (\$70,000.00).

SECTION 2. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.








ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, County of Nassau (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent
