**SECOND AMENDMENT TO CONTRACT FOR
WATER TREATMENT & MAINTENANCE SERVICES**

THIS SECOND AMENDMENT TO THE CONTRACT FOR WATER TREATMENT & MAINTENANCE SERVICES (hereinafter “Amendment”) is made by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida (hereinafter the “County”), and **CONSOLIDATED WATER GROUP, LLC**, a business having its primary business location at 44 SE 1st Avenue #311, Ocala, Florida 34471 (hereinafter the “Vendor”).

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Water Treatment & Maintenance Services dated November 14, 2022 (hereinafter “Contract”) which provided for an initial term through September 30, 2023; and

WHEREAS, the Contract was amended by way of the First Amendment to Contract for Water Treatment & Maintenance Services on August 18, 2023 to renew the Contract for an additional one (1) year period through September 30, 2024; and

WHEREAS, the Parties failed to formally renew the Contract prior to September 30, 2024, but the Parties have continued to perform their duties and responsibilities under the Contract and the Parties agree that by doing so, there was an implied renewal of the terms; and

WHEREAS, the Parties now desire to formally amend the Contract terms and conditions to memorialize their agreement subject to the provisions contained herein.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 19. of the Contract is hereby amended to renew the Contract for an additional one (1) year period and the Contract shall now terminate on September 30, 2025.

SECTION 2. Upon execution of this Amendment and in accordance with Section 787.06, Florida Statutes, the Vendor shall provide an affidavit to the County, on a form approved by the County, signed by an officer or representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.

SECTION 3. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.



From time to time, County of Nassau (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee.
