

Scope of Services – Boundary Survey

SAM will perform a boundary survey Parcel 38-2N-27-0000-0001-0150 and prepare 2 boundary surveys for the Christian Way Extension parcel and the residual parcel as shown on attached Exhibit "A".

- Recover sufficient boundary, right of way, and centerline corners to determine the location of Parcel 38-2N-27-0000-0001-0150.
- Set the boundary corners for both parcels per Florida Statutes Chapter 177.

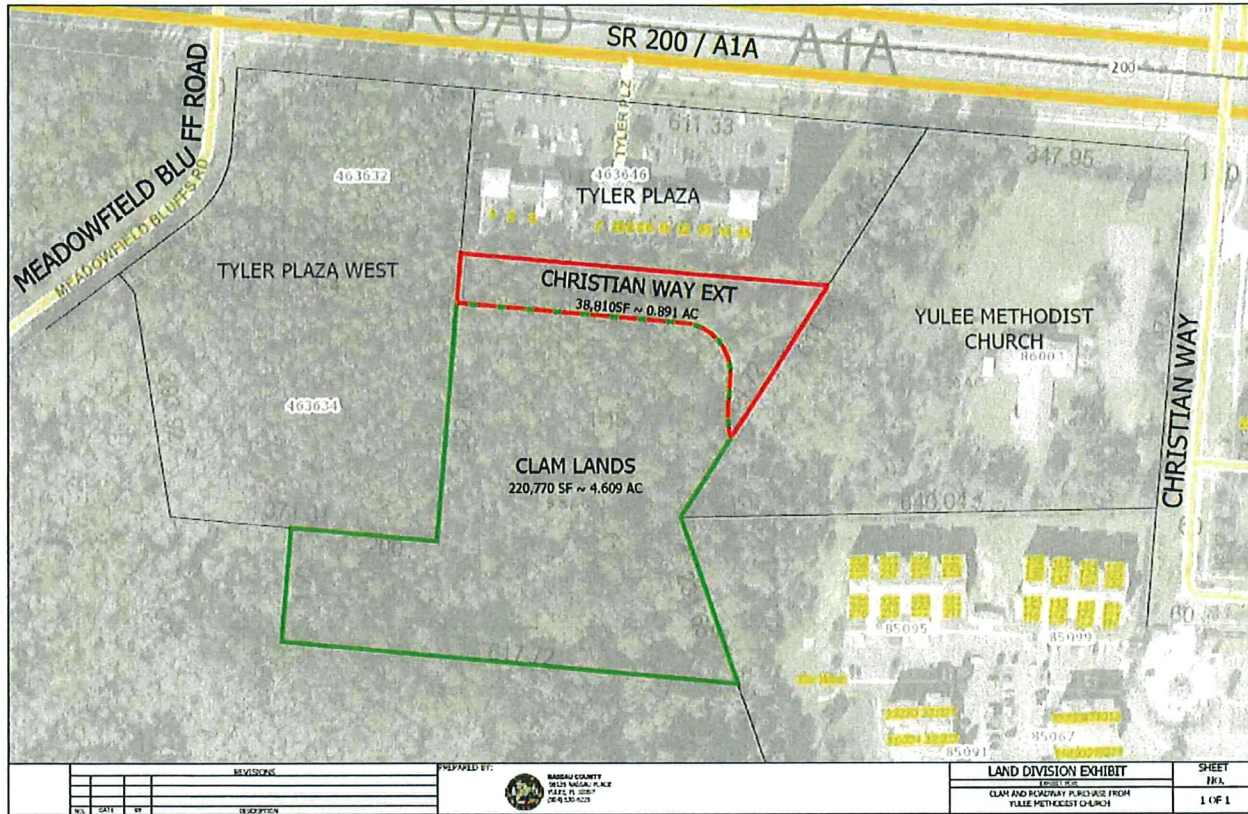
