## FIRST AMENDMENT TO CONTRACT FOR DELIVERY OF ROAD FILL/STABILIZING MATERIALS

THIS FIRST AMENDMENT TO THE CONTRACT FOR DELIVERY OF ROAD FILL/ STABILIZING MATERAILS (hereinafter "Amendment") is made by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter the "County"), and TIM-PREP, INC., a business having its primary business location at 18850 Macclenny Road, Jacksonville, Florida 32234, (hereinafter the "Vendor").

## WITNESSETH:

**WHEREAS**, the Parties previously entered into a Contract for Delivery of Road Fill/Stabilizing Materials dated February 12, 2024 (hereinafter "Contract") which provided for a term ending September 30, 2024; and

**WHEREAS**, the Parties failed to amend the Contract to formally extend the term of the Contract beyond September 30, 2024, but the Parties continued to perform their contractual duties and responsibilities under the Contract, and the Parties agree by this performance there was an implied extension for the performance period of the Contract; and

**WHEREAS**, the Parties now desire to formally amend the Contract terms and conditions to memorialize their Agreement subject to the provisions contained herein.

**NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** Section 6. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on September 30, 2025.

**SECTION 2.** Section 4. of the Contract is hereby amended to increase the compensation amount for the goods/services to be provided under the Contract by Three Hundred Sixty Thousand Dollars and 00/100 (\$360,000.00) and the County shall now compensate the Vendor in an amount not to exceed One-Million, Five-Hundred Fifty Thousand Dollars and 00/100 (\$1,550,000.00).

**SECTION 3.** The Contract is further amended to add a new section as follows:

## **SECTION 40. Human Trafficking Affidavit.**

**40.1** In accordance with Section 787.06, Florida Statutes, the Vendor shall provide the County with an affidavit, on a form approved by the County, signed by an officer or a representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.

**SECTION 4.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
