FIRST AMENDMENT TO THE RIGHT OF WAY RESERVATION AGREEMENT

This First Amendment to the Right of Way Reservation Agreement ("Amendment") is made and entered into by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, a political subdivision of the State of Florida (the "County"), RAYDIENT LLC, d/b/a RAYDIENT PLACES + PROPERTIES LLC, a Delaware limited liability company ("Raydient") and WILDLIGHT LLC, a Delaware limited liability company ("Wildlight"), as of the 18th day of December .2024.

RECITATION OF FACTS

- A. WHEREAS, the County, Raydient (as a successor by merger and name change to TerraPointe LLC) and Wildlight (as a successor to Rayonier Forest Resources, L.P.) entered into that certain Right of Way Reservation Agreement, dated February 14, 2007 and recorded at Official Records Book 1486, Page 1820 of the public records of Nassau County, Florida (the "Agreement") to provide for the reservation of a 1,000-foot-wide transportation corridor, within which a new road right of way would be located ("C.R. 108 Right of Way") in the East Nassau Community Planning Area ("ENCPA"); and
- B. WHEREAS, the Agreement generally identified the location of the C.R. 108 Right of Way in its Exhibit "A" thereto, which consisted of a one-page map and no legal description; and
- C. WHEREAS, the ENCPA is a state approved sector plan pursuant to Section 163.3245, Florida Statutes; and
- D. WHEREAS, the County, Raydient (as a successor by merger and name change to TerraPointe LLC), and Raydient-related entities next entered into that certain ENCPA Proposed Transportation Improvements and Mobility Fee Agreement, dated June 24, 2013 and recorded at Official Records Book 1866, Page 1416 of the public records of Nassau County, Florida, as amended by that First Amendment, dated July 20, 2015 and recorded at Official Records Book 1993, Page 22 of the public records of Nassau County, Florida, and by that Second Amendment, dated October 25, 2021, and recorded at Official Records Book 2509, Page 1962 of the public records of Nassau County, Florida, and as may be further amended (collectively the "Mobility Fee Agreement"); and

- E. WHEREAS, the Mobility Fee Agreement provides the method to mitigate ENCPA development transportation/mobility impacts and creates a funding mechanism for such mitigation; and
- F. WHEREAS, the County adopted the ENCPA Detailed Specific Area Plan (DSAP) #2 Development Order (the "DSAP DO") by enacting Ordinance No. 2023-044 on November 27, 2023; and
- G. WHEREAS, the DSAP DO sets forth certain development conditions to mitigate for transportation and mobility impacts associated with development within the DSAP consistent with the Mobility Fee Agreement; and
- H. WHEREAS, the C.R. 108 Right of Way is one of the ENCPA transportation/mobility mitigation roadways provided for in the Mobility Fee Agreement and the DSAP DO; and
- I. WHEREAS, the C.R. 108 Right of Way is referred to as the CR 108 Extension in the Mobility Fee Agreement, as Wildlight Parkway in the DSAP DO, and as Riverbluff Parkway in site engineering plans and relevant permits; and
- J. WHEREAS, the County, Raydient, and Wildlight desire to enter into this Amendment to resolve title issues by clarifying the width and location of the C.R. 108 Right of Way as identified in the Agreement; and
- K. WHEREAS, the required public hearings were held, with proper notice provided; and
- **NOW**, **THEREFORE**, in consideration of the mutual covenants herein set forth, together with other good and valuable consideration, the County, Raydient, and Wildlight agree to the terms of this Amendment as follows:

AGREEMENT OF THE PARTIES

- 1. <u>Recitals</u>. The matters set forth in the Recitation of Facts paragraphs of this Amendment are true and correct as of the date hereof and are incorporated herein by reference.
- 2. <u>Definitions</u>. Unless otherwise defined, all capitalized terms used herein shall have the meanings as set forth in the Agreement.
 - 3. <u>Agreement Amendments</u>. The Agreement is hereby amended as follows:
 - (a) Exhibit "A" to the Agreement is hereby deleted and replaced with Exhibit "A" attached to this Amendment.
 - (b) The "Rayonier Entities" as defined in the Agreement are hereby amended to refer to Raydient and Wildlight.
 - (c) Section 1. of the Agreement is hereby amended as shown in strike-through

and underlined and replaced with the following:

- 1. The Rayonier Entities agree upon the approval of this Agreement to reserve a one hundred and fifty (150) thousand (1000) foot wide right of way transportation corridor on their lands described and located generally as shown on the attached Exhibit A within which a one hundred forty foot right of way for the New Road will be located ("C.R. 108 Right of Way"). The design and timing of construction of the New Road within the C.R. 108 Right of Way will be consistent with the East Nassau Community Planning Area Detailed Specific Area Plan (DSAP) #2 Development Order approved by the Board of County Commissioners under Ordinance 2023-44 ("DSAP 2 DO"). As the final design of the New Road is contingent on multiple factors presently undetermined such as environmental permits from the St. Johns Water Management District and the US Corps of Army Engineers, phasing, timing, funding source, relationships to adjacent land uses and a secondary roadway system, the preliminary design criteria are subject to change. The issue of access on the New Road will be addressed upon receipt of any of several possible planning documents or application for development approval (e.g., DSAP 2 DO, relevant Preliminary Development Plan, site engineering plan, etc.). It is understood by the parties that donation of land from Rayonier Entities for the C.R. 108 Right of Way will be a gratuitous donation and there shall be no development or mitigation rights or credit associated with this donation.
- 4. <u>Mobility Agreement</u>. This Amendment is consistent with the Mobility Agreement and does not modify, adjust or otherwise amend the Mobility Agreement, except that any references to the Agreement contained therein shall be construed as including this Amendment.
- 5. <u>DSAP DO</u>. This Amendment is consistent with the DSAP DO and does not modify, adjust or otherwise amend the DSAP DO, except that any references to the Agreement contained therein shall be construed as including this Amendment.
- 6. <u>Effective Date</u>. This Amendment shall be effective upon recordation in the public records of Nassau County, Florida.
- 7. <u>Agreement</u>. Except as specifically amended by this Amendment, the Agreement remains in full force and effect.
- 8. <u>Counterparts</u>. This Amendment may be signed in several counterparts, each of which shall be deemed an original and all such counterparts together shall constitute one and the same instrument.




MAP SHOWING SKETCH AND LEGAL DESCRIPTION OF






