**FUNDING AGREEMENT WITH FOUR TWENTY ONE HEROES INC**  
**FISCAL YEAR 2024/2025**

THIS FUNDING AND SPONSORSHIP AGREEMENT (“Agreement”) is entered into by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY**, a political subdivision of the State of Florida, hereinafter referred to as “County”, and **FOUR TWENTY ONE HEROES INC**, a Florida not for profit corporation **d/b/a/Hands4Hearts** whose address is 85372 FALLEN LEAF DR, FERNANDINA BEACH, FL 32034, hereinafter referred to as “Heroes”.

**RECITALS**

**WHEREAS**, Heroes provides health services for residents in Nassau County, Florida, including CPR Training and Education; and

**WHEREAS**, the County recognizes that it is in the best interest of the citizens of Nassau County, Florida, that Heroes continues to provide said health services; and

**WHEREAS**, the County desires to enter into this funding agreement with Heroes in order to sponsor said health services.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

**SECTION 1. RECITALS.**

1.1 The above recitals are true and correct and are incorporated herein, in their entirety, by this reference.

**SECTION 2. FUNDING AND HEROES’ RESPONSIBILITIES.**

2.1. For the services outlined in this Agreement, the County will pay Heroes the sum of TWELVE THOUSAND EIGHT HUNDRED AND 00/100 DOLLARS (\$12,800.00). The funds are to be used for CPR Training and Education benefitting Nassau County citizens, including a direct mail CPR education campaign; a social media CPR education campaign; and a minimum of 12 CPR training classes.

(a) In exchange for the above-referenced funding, Heroes agrees to recognize Nassau County Board of County Commissioners as a sponsor on all printed and electronic materials.

2.2 In performing its obligation under this Agreement, Heroes shall be at all times acting in the capacity of an independent contractor and not as an officer, employee or agent of

the County.

2.3 Heroes shall submit simultaneously to the County Manager and the Nassau County Clerk of Courts an annual accounting acceptable to the Clerk on or before December 31<sup>st</sup> of each fiscal year in which Heroes received funding from the County. Additionally, Heroes shall make its books available for inspection by a designee of the County upon reasonable notice. Failure of Heroes to provide the annual accounting record by the time specified shall result in the revocation of granting of further funds and reimbursement of funds distributed during the year for which no report was submitted.

2.4 Appropriations necessary for the funding of this Agreement beyond the FY 2024/2025 shall be subject to the budget and appropriation by the County during the regular budget process.

**SECTION 3. TERM OF AGREEMENT AND OPTION TO AMEND.**

3.1 The term of this Agreement shall commence on February 1, 2025 and terminate on October 1, 2025, unless terminated by either party by giving thirty (30) days written notice to the other party, subject to completion of all previous and outstanding billings.

3.2 This Agreement may be amended only in writing by mutual consent of the parties.

**SECTION 4. THE AMERICANS WITH DISABILITIES ACT, FLORIDA PUBLIC RECORDS LAW.**

4.1 All facilities, programs and services will be compliant with the Florida Accessibility Code and the Federal Americans with Disabilities Act (ADA). Failure to provide facilities, programs, or services that are compliant with both the Florida Accessibility Code and the Federal Americans with Disabilities Act (ADA) shall be considered a breach of the Agreement and may result in termination of this Agreement.

4.2 The County is a public agency subject to Chapter 119, Florida Statutes. **IF HEROES HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO HEROES' DUTY TO PROVIDE PUBLIC RECORDS RELATING TO THIS AGREEMENT, CONTACT THE CUSTODIAN OF PUBLIC RECORDS AT (904) 530-6090, [RECORDS@NASSAUCOUNTYFL.COM](mailto:RECORDS@NASSAUCOUNTYFL.COM), 96135 NASSAU PLACE, SUITE 6, YULEE, FLORIDA 32097.** Under this Agreement, to the extent that Heroes is

providing goods and/or services to the County, and pursuant to Section 119.0701, Florida Statutes, Heroes shall:

a. Keep and maintain public records required by the County to provide goods and/or services.

b. Upon request from the County's custodian of public records, provide the County with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in this chapter or as otherwise provided by law.

c. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the Agreement term and following completion of the Agreement if Heroes does not transfer the records to the County.

d. Upon completion of the Agreement, transfer, at no cost, to the County all public records in possession of Heroes or keep and maintain public records required by the County to perform the service. If Heroes transfers all public records to the County upon completion of the Agreement, Heroes shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If Heroes keeps and maintains public records upon completion of the Agreement, Heroes shall meet all applicable requirements for retaining public records. All records stored electronically shall be provided to the County, upon request from the County's custodian of public records, in a format that is compatible with the information technology systems of the County.

4.3 A request to inspect or copy public records relating to the County's agreement for goods and/or services shall be made directly to the County. If the County does not possess the requested records, the County shall immediately notify Heroes of the request, and Heroes shall provide the records to the public agency or allow the records to be inspected or copied within a reasonable time.

4.4 If Heroes does not comply with the County's request for records, the County shall enforce the Agreement provisions in accordance with the Agreement.

4.5 If Heroes fails to provide the public records to the County within a reasonable time, Heroes may be subject to penalties under Section 119.10, Florida Statutes.

4.6 If a civil action is filed against Heroes to compel production of public records relating to the Agreement, the Court shall assess and award against Heroes the reasonable costs

of enforcement, including reasonable attorney fees if:

(a) The Court determines that Heroes unlawfully refused to comply with the public records request within a reasonable time; and

(b) At least eight (8) business days before filing the action, the plaintiff provided written notice of the public records request, including a statement that Heroes has not complied with the request, to Heroes and to the County.

4.7 A notice complies with this Section, if it is sent to the County's custodian of public records and to Heroes at Heroes' address listed on its Agreement with the County or to Heroes' registered agent. Such notices shall be sent to the address listed above for each party.

4.8 If Heroes complies with a public records request within eight (8) business days after the notice is sent, Heroes shall not be liable for the reasonable costs of enforcement.

**SECTION 5. TERMINATION.**

5.1 If Heroes fails to perform any of its obligations under this Agreement, and if such default remains uncured for more than fifteen (15) days after written notice was provided by the County, then the County may, without prejudice to any right or remedy the County may have, terminate this Agreement and cease payment.

5.2 The County reserves the right to terminate this Agreement in whole or part by giving Heroes written notice at least thirty (30) days prior to the effective date of termination.

**SECTION 6. GOVERNING LAW, VENUE, AND COMPLIANCE WITH LAWS.**

6.1 This Agreement shall be deemed to have been executed and entered into within the State of Florida and any dispute arising hereunder, shall be governed, interpreted and construed according to the laws of the State of Florida, the Ordinances of Nassau County, and any applicable federal statutes, rules and regulations. Any and all litigation arising under this Agreement shall be brought in Nassau County, Florida, and any trial shall be non-jury. Any mediation, pursuant to litigation, shall occur in Nassau County, Florida.

6.2 Heroes shall comply with any applicable regulatory requirements including federal, state, and local laws, rules, regulations codes, orders, criteria and standards.

**SECTION 7. NO ASSIGNMENT.**

7.1 Heroes shall not assign, sublet, convey or transfer its interest in this Agreement without the prior written consent of the County.

**SECTION 8. EVENT CANCELLATION.**

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

### **Getting paper copies**
