SECOND AMENDMENT TO CONTRACT FOR METAL CULVERTS

WHEREAS, the Parties previously entered into the Contract for Metal Culverts dated May 22, 2023 (hereinafter "Contract") and an Amendment to Contract for Metal Culverts on April 30, 2024; and

WHEREAS, the Parties now desire to further amend the Contract terms and conditions subject to the provisions contained herein.

NOW, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 20. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on May 21, 2026.

SECTION 2. Upon execution of this Amendment, the Vendor shall, in accordance with Section 787.06, Florida Statutes, provide the County an affidavit, on a form approved by the County, signed by an officer or a representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.

SECTION 3. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
