

**THIRD AMENDMENT TO CONTRACT FOR PROFESSIONAL SERVICES**

**THIS THIRD AMENDMENT TO THE CONTRACT FOR PROFESSIONAL SERVICES** (hereinafter “Amendment”) is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the “County”), and **LIBERTY PARTNERS OF TALLAHASSEE, LLC**, a business having its primary business location at 113 E. College Avenue, Suite 400, Tallahassee, Florida 32302 (hereinafter the “Consultant”).

**WITNESSETH:**

**WHEREAS**, the Parties previously entered into a Contract for grant management and consulting services dated October 19, 2022 (hereinafter “Contract”); and

**WHEREAS**, the Parties previously entered into the First Amendment to the Contract for Professional Services dated October 18, 2023 (hereinafter “Contract”); and

**WHEREAS**, the Parties previously entered into the Second Amendment to the Contract for Professional Services dated October 10, 2024 (hereinafter “Contract”); and

**WHEREAS**, the Parties are seeking to pursue additional grant opportunities through the services of the Consultant; and

**WHEREAS**, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

**NOW, THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** Attachment “A” as referenced in Article 5, at Section 5.1, and the fee for service under the Contract is hereby amended and the County shall now compensate the Consultant in an amount not to exceed One Hundred Thousand Dollars and 00/100 (\$100,000.00) for Fiscal Year 2024/25 for a total contracted not to exceed amount of Two Hundred Thousand Dollars and 00/100 (\$200,000.00). All other terms and conditions of Attachment “A” not inconsistent with the provisions of this Section shall remain the same and in full force and effect.

**SECTION 2.** Upon execution, renewal or extension of this Contract, the Consultant shall provide the County on a form approved by the County an affidavit signed by an officer or a representative of the Consultant under penalty of perjury attesting that the Consultant does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.

**SECTION 3.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
