FIRST AMENDMENT TO CONTRACT FOR LANDSCAPE MAINTENANCE SERVICES

THIS FIRST AMENDMENT TO THE CONTRACT FOR LANDSCAPE MAINTENANCE SERVICES (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and COASTAL GREENERY, INC., a business having its primary business location at 1242 Old Jesup Road, Brunswick, GA 31520 (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Additional Mowing, Landscape Maintenance, and Other Related Services at the new structure located at the Nassau County Sheriff's Office Training Complex and Gun Range dated January 31, 2025 (hereinafter "Contract"); and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

NOW, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 6. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on September 30, 2026.

SECTION 2. Pursuant to Section 6.1 of the Contract, the annual compensation amount of the Contract is hereby increased by three percent (3%) to a sum of Sixteen Thousand Four Hundred and Eighty Dollars (\$16, 480.00). The County shall now compensate the Vendor in an amount not to exceed Thirty-Two Thousand Four Hundred Eighty Dollars and 00/100 (\$32,480.00) for the goods and services provided hereunder.

SECTION 3. Contracting with entities of foreign countries of concern prohibited. In accordance with Section 287.138, Florida Statutes, the Vendor shall provide the County an affidavit, on a form approved by the County, signed by an officer or representative of the Vendor under penalty of perjury attesting that the Vendor will comply with all requirements of Section 287.138, Florida Statutes.

SECTION 4. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
