# SECOND AMENDMENT TO CONTRACT FOR EMPLOYEE BACKGROUND SERVICES FOR NASSAU COUNTY, FLORIDA

THIS SECOND AMENDMENT TO THE CONTRACT FOR EMPLOYEE BACKGROUND SERVICES (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and ALERTCHECKS, INC., a business having its primary business location at 400 State Road 436, Suite 206, Casselberry, Florida 32707 (hereinafter the "Vendor").

#### **WITNESSETH:**

**WHEREAS**, the Parties previously entered into a Contract for Employee Background Services dated July 11, 2022 (hereinafter "Contract"); and

**WHEREAS**, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

**NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** Article 4 of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on July9, 2026.

**SECTION 2.** Article 5. is amended in order to increase the compensation amount under the Contract to an amount not to exceed Twenty-Nine Thousand Nine Hundred and Nineteen Dollars and 00/100 (\$29, 919.00). All other terms and conditions of this Article shall remain the same.

**SECTION 3.** Upon execution, renewal or extension of this contract, Vendor shall provide the County an affidavit signed by an officer or a representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.

**SECTION 4.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
