# FIRST AMENDMENT TO CONTRACT FOR GARAGE DOOR PRVENTATIVE MAINTENANCE SERVICES

THIS FIRST AMENDMENT TO THE CONTRACT FOR GARAGE DOOR PREVENTATIVE MAINTENANCE SERVICES (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and The Lenape Group, LLC dba Vigneaux Corporation, a business having its primary business location at 5863 West Beaver Street Jacksonville, FL 32254 (hereinafter the "Vendor").

#### WITNESSETH:

**WHEREAS**, the Parties previously entered into a Contract for Garage Door Preventative maintenance, Inspection, and Repair Services for multiple County locations dated January 9, 2023 (hereinafter "Contract"); and

**WHEREAS**, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

- **NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:
- **SECTION 1.** Section 19. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) (year) and the Contract shall now terminate on September 30, 2026.
- **SECTION 2.** The Contract is hereby amended to increase the compensation amount for the goods/services by Thirteen Thousand Eight Hundred and Sixty Dollars and 00/100 (\$13,860.00). The County shall now compensate the Vendor in an amount not to exceed Fifty-Five Thousand Four Hundred and Forty Dollars and 00/100 (\$55,440.00).
- **SECTION 3**. Human Trafficking Affidavit. In accordance with Section 787.06, Florida Statutes, the Vendor shall provide the County an affidavit, on a form approved by the County, signed by an officer or representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.
- **SECTION 4.** Contracting with entities of foreign countries of concern prohibited. In accordance with Section 287.138, Florida Statutes, the Vendor shall provide the County an affidavit, on a form approved by the County, signed by an officer or representative of the Vendor under penalty of perjury attesting that the Vendor will comply with all requirements of Section 287.138, Florida Statutes.
- **SECTION 5.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
