**SECOND AMENDMENT TO CONTRACT FOR ON-SITE SERVICES**

**THIS SECOND AMENDMENT TO THE CONTRACT FOR ON-SITE SERVICES** (hereinafter “Amendment”) is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the “County”), and Smiths Detection Inc., a business having its primary business location at 2202 Lakeside Boulevard, Edgewood, MD 21040 (hereinafter the “Vendor”).

**WITNESSETH:**

**WHEREAS**, the Parties previously entered into a Contract for On-Site Services dated December 13, 2022 (hereinafter “Contract”); which was amended on July 1, 2024, to extend the performance period of the original contract through June 12, 2025 and to increase the contract amount to Fourteen Thousand, Nine Hundred Twenty-Three Dollars and 00/100 (\$14, 923.00); and

**WHEREAS**, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

**NOW, THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** Exhibit “A” Vendor’s Service Quotation is hereby amended to reflect updated pricing for the additional year, a copy of Exhibit “A” is attached hereto.

**SECTION 2.** Section 19. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and to increase the compensation amount for the goods/services by an additional Six Thousand, Five Hundred Twenty-Nine Dollars and 00/100 (\$6,529.00). The Contract shall now terminate on June 11, 2026, and the County shall compensate the Vendor in a total amount not to exceed Twenty-One Thousand, Four Hundred, Fifty-Two Dollars and 00/100 (\$21,452.00).

**SECTION 3.** Section 40. In accordance with Section 787.06, Florida Statutes, the Vendor shall provide the County an affidavit, on a form approved by the County, signed by an officer or representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.

**SECTION 4.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
