**SECOND AMENDMENT TO AGREEMENT FOR PROFESSIONAL
BEAVER REMOVAL SERVICES FOR NASSAU COUNTY, FLORIDA**

THIS SECOND AMENDMENT TO THE AGREEMENT FOR PROFESSIONAL BEAVER REMOVAL SERVICES FOR NASSAU COUNTY, FLORIDA (hereinafter “Amendment”) is made by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter the “County”), and STARLING PROPERTY SOLUTIONS, a business having its primary business location at 575 Otis Road, Jacksonville, FL, 32220 (hereinafter the “Vendor”).

WITNESSETH:

WHEREAS, the Parties previously entered into an Agreement for Professional Beaver Removal Services for Nassau County, Florida dated November 25, 2021 (hereinafter “Contract”) which provided for an initial three-year term ending September 30, 2024;

WHEREAS, the Parties then entered into that certain First Amendment to the Contract, dated September 27, 2024, to increase the compensation to Vendor and to extend the term of the Contract for another one-year term, which is set to end on September 30, 2025; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 4. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on September 30, 2026.

SECTION 2. Section 5.1 of the Contract is hereby amended to increase the compensation amount for the services to be provided due to extending the term an additional one (1) year. The County shall now compensate the Vendor for an additional Two-Thousand Six Hundred and 00/100 Dollars (\$2,600.00), for a total amount not to exceed Eleven Thousand Five Hundred and 00/100 Dollars (\$11,500.00) for the initial three-year term and two one-year renewal terms.

SECTION 3. In accordance with Section 787.06, Florida Statutes, the Vendor shall provide the County with an affidavit, on a form approved by the County, signed by an officer or a representative of the Vendor under penalty of perjury attesting that the Vendor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.

SECTION 4. Upon execution of this Amendment, and in accordance with Section 287.138, Florida Statutes, the Vendor shall provide the County an affidavit, on a form approved by the County, signed by an officer or representative of the Vendor under penalty of perjury attesting that the Vendor will comply with all requirements of Section 287.138, Florida Statutes.

SECTION 5. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, County of Nassau (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent
