# SECOND AMENDMENT TO DESIGN-BUILD SERVICES CONTRACT Nassau Crossing Park Splash Pad

**THIS SECOND AMENDMENT TO DESIGN-BUILD SERVICES CONTRACT** ("**Amendment**") is made and entered into by and between the Board of County Commissioners of Nassau County, Florida (the "**Owner**" or "**County**"), and ACON Construction Co., Inc. ("**Design-Builder**").

# **BACKGROUND FACTS**

- **A.** Owner and Design-Builder entered into that certain Design-Build Services Contract dated July 23, 2024 for Design-Builder to perform the services for the Project as more particularly described in NC24-009-RFP-Request for Proposals for Design/Build Services for Splash Pad at Nassau Crossing Park issued by Owner (the "**Contract**"); and
- **B.** Owner and Design-Builder entered into that certain First Amendment to Design-Build Services Contract dated February 19, 2025, which included additional details regarding the Project; and
- **C.** Owner and Design-Builder desire to further amend the Contract to extend the completion of the Project by ninety (90) days as set forth herein.
- **NOW, THEREFORE**, in mutual consideration of the provisions contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree to amend the Contract as follows:
- **1.** <u>Background Facts.</u> The Background Facts as set forth above are agreed to be true and correct and incorporated herein by this reference.
- 2. <u>Scheduled Substantial Completion Date</u>. The Scheduled Substantial Completion Date, in accordance with Section 7.B of the Contract as amended by Section 5 of the First Amendment, is hereby amended and increased by an additional ninety (90) days, meaning the Scheduled Substantial Completion Date shall be two hundred forty (240) days following the date the Design-Builder received its permits for the Project.
- **3.** Guaranteed Completion Date. The Guaranteed Completion Date shall remain as 15 (fifteen) days after the Substantial Completion Date.
- **4.** <u>Human Trafficking.</u> In accordance with Section 787.06, Florida Statutes, the Design-Builder shall provide the County an affidavit, on a form approved by the County, signed by an officer or representative of the Design-Builder under penalty of perjury attesting that the Design-Builder does not use coercion for labor or services as defined in Section 787.06, Florida Statutes.
  - 5. Contracting with Entities of Foreign Countries of Concern. In

accordance with Section 287.138, Florida Statutes, the Design-Builder shall provide the County an affidavit, on a form approved by the County, signed by an officer or representative of the Design-Builder under penalty of perjury attesting that the Design-Builder will comply with all requirements of Section 287.138, Florida Statutes.

**6.** All other terms and conditions of the Contract, as amended, that are not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
