**SECOND AMENDMENT TO CONTRACT FOR DELIVERY OF ROAD FILL/
STABILIZING MATERIALS**

THIS SECOND AMENDMENT TO THE CONTRACT FOR ROAD FILL/ STABILIZING MATERIALS (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and Tim-Prep, Inc., a business having its primary business location at 18850 Macclenny Road, Jacksonville, Florida 32234, (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Delivery of Road Fill/ Stabilizing Materials dated February 12, 2024 (hereinafter "Contract") which provided for a term ending September 30, 2024; and

WHEREAS, on December 18, 2024, the Contract was amended to extend the term of the Contract for an additional one (1) year and to increase the compensation amount by Three Hundred and Sixty Thousand Dollars and 00/100 (\$360,000.00) (hereinafter "First Amendment"); and

WHEREAS, The Parties now desire to amend the Contract further to increase the not to exceed amount by an additional Three Hundred and Sixty Thousand Dollars and 00/100 (\$360,000.00) ; and

WHEREAS, the Parties further desire to extend the term of the Contract for an additional one (1) year; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 6 of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year, and the Contract shall now terminate on September 30, 2026.

SECTION 2. Section 4 of the Contract is hereby amended to increase the compensation amount for the goods/services to be provided under the Contract by Three Hundred Sixty Thousand Dollars and 00/100 (\$360,000.00) and the County shall now compensate the Vendor in an amount not to exceed One-Million, Thirty Thousand Dollars and 00/100 (\$1,030,000.00).

SECTION 3. The Contract is further amended to add a new section as follows:

SECTION 41. Foreign Countries of Concern Affidavit.

41.1 Upon execution of this Amendment, and in accordance with Section 287.138, Florida Statutes, the Vendor shall provide the County an affidavit, on a form approved by the County, signed by an officer or representative of the Vendor under penalty of perjury attesting that the Vendor will comply with all requirements of Section 287.138, Florida Statutes.

SECTION 4. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.

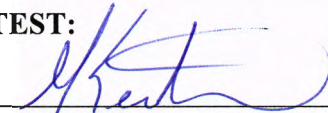
