AN ORDINANCE ASSESSING COSTS AGAINST ANY PERSON CONVICTED FOR VIOLATION OF ANY COUNTY ORDINANCE OR FROM EVERY BOND ESTREATED OR FORFEITED BAIL BOND RELATED TO SUCH PENAL ORDINANCES AS HEREINAFTER DESCRIBED; AND PROVIDING WHEN SAID ORDINANCE SHALL TAKE EFFECT

BE IT ENACTED BY THE PEOPLE OF THE COUNTY OF NASSAU, FLORIDA:

SECTION 1. Any defendant convicted or fined in the County Court of Nassau County shall have collected from him the amount of \$2.00 as court costs imposed by the County Judge or collected by the County Clerk.

SECTION 2. In addition to the assessment set forth in Section 1 above, there shall be assessed and collected the sum of two dollars (\$2.00) as a Court Cost from every bond estreature or forfeited bail bond related to such penal ordinance referred to in Section 1 above.

SECTION 3. Of the two dollars (\$2.00) collected in Sections 1 and 2 above, one dollar (\$1.00) of which shall be forwarded to the state treasurer as provided by Section 23.091, Florida Statutes, as amended; and one dollar (\$1.00) of which shall be transferred to a special fund of the County of Nassau for law enforcement education expenditures for its law enforcement officers as provided by Section 23.091, Florida Statutes, as amended, and this ordinance.

Section 4. All ordinances or parts of ordinances in conflict herewith or inconsistent with the provisions of this ordinance are hereby repealed.

Section 5. That this ordinance shall take effect immediately after its final passage and publication.
