

ORDINANCE 87-2

AN ORDINANCE CREATING A NASSAU COUNTY BASED REHABILITATIVE ALCOHOL PROGRAM; CREATING A SPECIAL FUND TO BE KNOWN AS THE "SPECIAL ALCOHOL REHABILITATIVE TRUST FUND"; AUTHORIZING USE OF SAID FUNDS FOR THE SUPPORT OF SUCH PROGRAM; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Board of County Commissioners of Nassau County have been made aware of the need for funding for a Nassau County Alcohol Rehabilitative Program, and

WHEREAS, Said Alcohol Rehabilitative Program can be funded from fines received from all alcohol related offenses, and

WHEREAS, The Board of County Commissioners of Nassau County finds that there is need for said fund, and

NOW THEREFORE BE IT ORDAINED by the Board of County Commissioners of Nassau County, Florida that:

SECTION I: Special Alcohol Rehabilitative Trust Fund -

There is hereby created a trust fund account to be known as the "Special Alcohol Rehabilitative Trust Fund.

SECTION II: Funding -

There is hereby imposed a surcharge of ten (\$10.00) dollars to be imposed on all fines imposed by the County Court of Nassau County for alcohol related offenses under Section 316.193, 316.1931, 860.03 and 860.13 Florida Statutes.

SECTION III: Creation of Fund -

All monies collected pursuant to the surcharge amount stated in Section II shall be deposited in the trust fund account to be known as the "Special Alcohol Rehabilitative Trust Fund". These monies shall be used only for support of Nassau County based Nassau County Alcohol Rehabilitative Programs.

SECTION IV: Disbursement -

The Clerk of the Court is authorized and directed to make

disbursement from this account upon written requisition from the locally designated agency responsible, and approved by the Nassau County Board of County Commissioners, for a Nassau County based Alcohol Rehabilitative Program.

SECTION V: Designated Agency -

The Board of County Commissioners of Nassau County shall designate the agency that will provide a Nassau County based Alcohol Rehabilitative Program and shall contract with said agency on an annual basis. The contract shall provide for an annual audit and appropriate review procedures.

SECTION VI: Effective Date -

This Ordinance shall become effective upon signature pursuant to Law.
