

ORDINANCE NO. 99-07

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, AMENDING ORDINANCE NO. 73-26, AS AMENDED, WHICH REGULATES THE INSTALLATION, ALTERATION, AND MAINTENANCE OF ALL PIPING EXTENDING FROM THE POINT OF DELIVERY OF GAS FOR USE AS A FUEL AND DESIGNED TO CONVEY OR CARRY THE SAME TO GAS APPLIANCES, AND REGULATING THE INSTALLATION AND MAINTENANCE OF APPLIANCES DESIGNED TO UTILIZE SUCH GAS AS A FUEL WITHIN THE UNINCORPORATED AREAS OF NASSAU COUNTY; SPECIFICALLY CHAPTER 2 TO ADOPT THE 1997 EDITION OF THE SOUTHERN STANDARD GAS CODE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners has found it in the best interest of the citizens of Nassau County, Florida, that the 1997 edition of the Southern Standard Gas Code.

NOW THEREFORE BE IT ORDAINED this 25th day of January, 1999 by the Board of County Commissioners of Nassau County, Florida, that Ordinance No. 73-26, shall be further amended as follows:

1. CHAPTER 2. PURPOSE AND SCOPE


The purpose of this Ordinance is to provide minimum standards, provisions and requirements for safe installation of consumer's gas piping and gas appliances. All such gas piping and gas appliances installed, replaced, maintained, or repaired within the limits of the County of Nassau shall conform to the requirements of this Ordinance and to specifications, rules and regulations ~~entitled "Installation of Consumer's Gas Piping and Gas Appliances" Southern Standard Gas Code, approved and adopted by the Board of County Commissioners of the County of Nassau, at its meeting held on the 31st day of July, 1973, by Ordinance No. 73-26,~~ pursuant to the Southern Standard Gas Code, 1997 edition, as promulgated by the Southern Building Code Congress International which specifications, rules and regulations are hereby incorporated herein by reference and made a part of this Ordinance as if fully set forth herein. Copies of such specifications, rules, and

regulations shall be kept on file in the Office of the Clerk of the Court of Nassau County. In any instance wherein Ordinance No. 73-26 as amended shall be in conflict with any of the provisions of this ordinance, the latter shall govern.

2. **EFFECTIVE DATE**

This Ordinance shall become effective upon its being filed with the Office of the Secretary of State.


