

RESOLUTION 97-188


A RESOLUTION INCREASING THE FEES SET FORTH FOR BUILDING, ELECTRICAL, MECHANICAL, AND PLUMBING PERMIT FEES, PURSUANT TO CHAPTER 7, ARTICLE 7-10, CODE OF LAWS AND ORDINANCES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Nassau County, Florida, find that it is in the best interest of the citizens of Nassau County that the fees paid for building, electrical, mechanical and plumbing fees to be amended.

NOW, THEREFORE, BE IT RESOLVED this 22nd day of September, 1997, by the Board of County Commissioners of Nassau County, Florida, as follows:

1. The Building, Electrical, Mechanical and Plumbing Fees set forth in Exhibit "A" attached to Resolution 94-168 shall be amended as shown in the attached Exhibit "A".
2. The fees set forth in this Resolution shall become effective on 1<sup>ST</sup> day of October, 1997.


