

RESOLUTION NO. 2002-190

**A RESOLUTION ESTABLISHING FEES FOR CONTRACTOR  
LICENSING PURSUANT TO ORDINANCE NO. 2002-42**

**WHEREAS**, the Board of County Commissioners of Nassau County, Florida, had previously adopted Resolution No. 2001-131 which set forth contractor licensing fees pursuant to Ordinance No. 86-1, as amended; and

**WHEREAS**, the Board of County Commissioners rescinded Ordinance No. 86-1, as amended, on September 16, 2002; and

**WHEREAS**, the Board of County Commissioners of Nassau County, Florida, adopted Ordinance No. 2002-42, an Ordinance Defining, Clarifying and Regulating Contractors and the business of contracting, on September 16, 2002.


