
A RESOLUTION ADOPTING RELEVANT PORTIONS OF THE NASSAU COUNTY CIVILITY CODE INTO THE PROCEDURES FOR HEARINGS BEFORE THE NASSAU COUNTY CODE ENFORCEMENT BOARD.

WHEREAS, the Code Enforcement Board has requested that the Board of County Commissioners add relevant portions of the Civility Code adopted by the Board of County Commissioners on January 28, 2002, as Resolution 2002-28, to the procedures for the Code Enforcement Board.

NOW, THEREFORE, BE IT RESOLVED this 25th day of February, 2002, by the Board of County Commissioners of Nassau County, Florida, as follows:

1. The provisions of Resolution 2002-28, a copy of which is attached, are hereby adopted for the Code Enforcement Board, except Paragraphs 5, 6, 9, and 10.
2. These provisions shall be effective immediately.



RESOLUTION 2002 - 028

A RESOLUTION ADOPTING THE NASSAU COUNTY CIVILITY CODE GOVERNING PROCEEDINGS BEFORE THE NASSAU COUNTY BOARD OF COUNTY COMMISSIONERS.

WHEREAS, the public has an absolute right to be heard and participate in meetings of the Board of County Commissioners; and

WHEREAS, it is in the best interest of the citizens of the County that all Board meetings be conducted in an orderly and civil manner.

NOW, THEREFORE, BE IT RESOLVED this 28th day of January, 2002, by the Board of County Commissioners of Nassau County, Florida, as follows:

1. All electronic devices, including cell phones and pagers, shall be turned off or otherwise silenced.
2. Prolonged conversations shall be conducted outside Commission Chambers.
3. Clapping, whistling, heckling, gesturing, loud conversations, or other disruptive behavior is prohibited.
4. Only those individuals who have submitted speaker cards and who have been recognized by the Chairman may address comments to the Board.
5. Comments at public hearings shall be limited to the subject being considered by the Board.

6. Comments at "Open to the Public" shall be directed to County issues.

7. All public comments shall avoid personal attacks, abusive language, and redundancy.

8. No person attending a board meeting is to harass, annoy, or otherwise disturb any other person in the room.

9. Time limits for "Open to Public" portion shall be limited to three (3) minutes.

10. Time limits for public hearings shall be established by the Board of County Commissioners at such meetings.

11. Any member of the public whose behavior is disruptive and violates the Nassau County Civility Code is subject to removal from the Board meeting by the Bailiff and such other action as may be appropriate.


