AN ORDINANCE ENTITLED AN ACT CREATING COURT SERVICE CHARGES FOR NASSAU COUNTY INCLUDING COUNTY AND CIRCUIT COURT; PROVIDING THAT SERVICE CHARGES IN EXCESS OF THOSE FIXED BY FLORIDA STATUTE SHALL BE CHARGED BY THE CLERK OF THE COURTS AND SUCH CHARGES SHALL BE USED IN PROVIDING AND MAINTAINING FACILITIES OF THE COURTS OF NASSAU COUNTY.

WHEREAS, the Clerk of the County and Circuit Court of Nassau County has requested that the Board of County Commissioners adopt Court fees in excess of those fixed by Florida Statutes, and

WHEREAS, the Board of County Commissioners finds that the charges requested are necessary to provide and maintain facilities for the Court of Nassau County, and

WHEREAS, the Board of County Commissioners further finds that it is in the best interests of the citizens of nassau County to enact said fees,

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Nassau County, Florida, that this Ordinance be passed to include the following:

<u>SECTION I</u>: The fees listed below shall be charged by the Clerk for the County and Circuit Court and said fees shall be in addition to those allowable by law:

(a)	County - Civil Small Claims: Claims of less than \$100.00\$ 2.00 Claims of \$100.00 and less than \$1,000.00\$ 4.00 Claims of \$1,000.00 or more\$ 8.00
(b)	Civil action, proceedings or
