A RESOLUTION RECOGNIZING THE NASSAU COUNTY
VOLUNTEER DIVE/RESCUE TEAM.

WHEREAS, several citizens of Nassau County have formed a volunteer dive, rescue team comprised of citizens with interests in fire/rescue and law enforcement; and

WHEREAS, the dive, rescue team members consist of support personnel and certified divers; and

WHEREAS, the Board of County Commissioners recognizes that the dive/rescue volunteer unit is dedicated to assisting law enforcement and fire/rescue personnel when needed.

NOW, THEREFORE, BE IT RESOLVED this 11th day of May, 1992, by the Board of County Commissioners of Nassau County, Florida, as follows:

1. The Board acknowledges and recognizes the Nassau Volunteer Dive, Rescue Team.
2. The Board recognizes the Team as a volunteer organization providing assistance to law enforcement and fire/rescue units within Nassau County, Florida.
3. The Nassau Volunteer Dive, Rescue Team shall not operate pursuant to any County policy or direction, but strictly as a


volunteer unit.

WHEREAS, water related recreational activities are vital elements in the lives of the citizens of Nassau County; and

WHEREAS, Florida's 8400 miles of saltwater tidal coastline, 3 million acres of inland lakes and 11,000 miles of rivers and streams provide for many of the needed outlets for recreation and relaxation; and

WHEREAS, recreational boating is one of Florida's leading outdoor activities with more than 4 million residents participating in this pastime; and

WHEREAS, Florida is the fastest growing recreational boating state in the nation with over 718,000 registered vessels and increasing at over 10,000 vessels each year; and

WHEREAS, every year lives are lost in boating accidents in spite of the educational efforts of the Florida Marine Patrol, U.S. Coast Guard Auxiliary, U.S. Power Squadrons, Florida Game and Fresh Water Fish Commission and local agencies; and

WHEREAS, the Florida Marine Patrol, U.S. Coast Guard, U.S. Coast Guard Auxiliary, U.S. Power Squadrons, Florida Game and Fresh Water Fish Commission and other cooperating agencies and groups have developed and are now executing campaigns in this field; and

WHEREAS, the sponsors of these safety programs have addressed their efforts to the youth and general public of Florida, urging them to enhance boating pleasure and avoid possible loss of life and property damage.

NOW, THEREFORE BE IT RESOLVED by the Nassau County Board of County Commissioners on behalf of the citizens to affirm and

support the goals of National Safe Boating Week, June 7-13, 1992,
and hereby proclaiming the week beginning June 7, 1992 as

NATIONAL SAFE BOATING WEEK

in Nassau County and urging all citizens who use our waterways to
join in learning and practicing safe boating and in having their
boats inspected for proper safety equipment.
