

NASSAU COUNTY, FLORIDA

ORDINANCE NO. 79-19

AN ORDINANCE ENTITLED AN ACT AMENDING CERTAIN FEES CHARGED IN NASSAU COUNTY, AMENDING ORDINANCE NUMBER 74-33, AMENDING APPENDIX A, ZONING ARTICLE III, SECTION 3, INCREASING COSTS FOR FILING OF APPLICATIONS FOR REZONING TO \$100.00; ZONING EXCEPTIONS TO \$50.00; P. U. D. to \$7.50 PER ACRE WITH A MINIMUM FEE OF \$150.00 AND A MAXIMUM OF \$500.00; VARIANCE FEE, \$50.00; APPEAL FEE, \$35.00; SETTING OTHER FEES: FOR AMBULANCE FEE, \$60.00; SEPTIC TANK FEE, \$50.00; PROVIDING FOR AN ENACTMENT DATE.

BE IT ORDAINED by the Board of County Commissioners of Nassau County, Florida:

SECTION I. The following schedule of fees shall apply to action under this Zoning Code. A receipt showing payment of the applicable fee shall accompany an application prior to consideration thereof. Such fees shall not include the cost of required advertisement which shall be placed and paid for by the applicant.

- a. An Application for Rezoning of Land.....~~\$50.00~~    \$100.00
- b. An Application for Zoning Exception.....~~\$25.00~~    \$ 50.00
- c. An Application for Rezoning to Planned Unit Development (PUD) ~~\$5.00~~ \$7.50 per acre (or part thereof) with a minimum fee of ~~\$100.00~~ \$150.00 and a maximum fee of \$500.00.
- d. An Application for Zoning Variance.....~~\$25.00~~    \$ 50.00
- e. An Application for an Appeal.....~~\$20.00~~    \$ 35.00

SECTION II. A fee of \$60.00 shall be charged for the use of or the initiating into use of any ambulance or ambulance service or rescue vehicle, either owned by, leased by, or in the service of the Board of County Commissioners of Nassau County.

SECTION III. The certification for a permit to utilize a septic tank for treatment of liquid and solid wastes in Nassau County, shall be \$50.00.
