

RESOLUTION 94 - 168

A RESOLUTION INCREASING THE FEES SET FORTH FOR BUILDING, ELECTRICAL, MECHANICAL, AND PLUMBING PERMIT FEES, PURSUANT TO CHAPTER 7, ARTICLE 7-10, CODE OF LAWS AND ORDINANCES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Nassau County, Florida, find that it is in the best interest of the citizens of Nassau County that the fees paid for building, electrical, mechanical, and plumbing permits be amended.


NOW, THEREFORE, BE IT RESOLVED this 8th day of August, 1994, by the Board of County Commissioners of Nassau County, Florida, as follows:

2. The fees set forth in this Resolution shall become effective on September 1, 1994.


