A RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION AND NASSAU COUNTY, FLORIDA REGARDING THE TRANSFER OF STATE ROAD 107

WHEREAS, the State has requested the transfer of State Road 107 from Santa Juana Road to State Road A1A, and Leg A/State Road 107A from State Road 107 to the Nassau River, from the State Highway System to the County Road System.


NOW, THEREFORE, BE IT RESOLVED this 10th day of February, 1997, by the Board of County Commissioners of Nassau County, Florida that:

1. John A. Crawford as representative of the Board of County Commissioners, is authorized to execute the agreement (attached), with the Florida Department of Transportation.

2. Nassau County accepts the roads including all rights of way, transferred into the Nassau County Road System, and all obligations under any maintenance, utility or railroad crossing agreements or other such agreements.

3. This resolution shall take effect upon the transfer of the funds from the Florida Department of Transportation as identified in the attached contract to the Board of County Commissioners.

# AGREEMENT

THIS AGREEMENT by and between the STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION (herein "FDOT"), and NASSAU COUNTY, FLORIDA (herein "Nassau"),

*gms* made this 4<sup>th</sup> day of ~~January~~ *March*, 1997.

## WITNESSETH:

WHEREAS, FDOT wishes to transfer a portion of State Road 107 and Leg A/SR 107A to the County and the County is willing to accept the transfer to the county road system under certain conditions.


NOW THEREFORE, in consideration of the premises and covenants hereinafter contained the parties agree as follows:

1. FDOT will transfer to Nassau County a portion of SR 107 and Leg A/SR 107A as shown on the attached right-of-way map of FDOT.
2. Nassau will accept the road transferred into the Nassau County road system for all purposes.
3. As part of the transfer procedure, FDOT will prepare and record on the public records of Nassau County, Florida, a map showing the roads transferred to Nassau.

4. FDOT shall pay Nassau upon the transfer the sum of One Hundred Fifty-Four Thousand and No/100 (\$154,000.00) Dollars, which funds are for the purpose of making certain roadway improvements to State Road 107/Leg A/State Road 107A.

IN WITNESS WHEREOF, the parties have caused their hands and seals to be set upon this Agreement the day and year first above written.


