

RESOLUTION 2005 - 76

A RESOLUTION ESTABLISHING AN EMERGENCY AND AUTHORIZING THE COUNTY ADMINISTRATOR IN CONJUNCTION WITH THE NASSAU AMELIA UTILITIES MANAGER TO OBTAIN A PURCHASE ORDER UP TO THE AMOUNT OF \$90,000.00 FOR SAID EMERGENCY AND ISSUE A NOTICE ~~TO~~ PROCEED TO COASTLINE UTILITY CONTRACTORS, INC.

WHEREAS, the Nassau Amelia Utilities ("NAU") Manager has advised the County Administrator of additional work that must be performed based upon the original emergency as set forth in Resolution 2005-69; and

WHEREAS, the notification by NAU of the additional work occurred on April 25, 2005; and

WHEREAS, based upon the emergency declared pursuant to Resolution 2005-69 and the additional work as set forth by the NAU Manager and the County Administrator, the proposed additional work must occur immediately in order to avoid loss of service, minimize costs, and to address immediate health and safety issues; and

WHEREAS, the nature of the emergency is such that it is necessary to call a special meeting at 3:00 p.m. on April 29, 2005, in order that work may commence immediately; and

WHEREAS, notices were prepared pursuant to County policy and press notifications utilized; and

WHEREAS, the Manager of NAU and the County Administrator, based upon quotes obtained, recommend Coastline Utility Contractors, Inc., to perform the work (a copy of the proposal is attached hereto as Exhibit "A").

NOW, THEREFORE, BE IT RESOLVED this 29th day of April, 2005, by the Board of County Commissioners of Nassau County, Florida, that:


1. The Board of County Commissioners hereby declares an emergency based upon Resolution 2005-69 and information presented by the NAU Manager and the County Administrator.

2. The Board hereby authorizes the County Administrator to obtain a Purchase Order up to the amount of \$90,000.00.

3. The Board hereby authorizes the County Administrator and the Manager of Nassau Amelia Utilities to instruct Coastline Utility Contractors, Inc., to commence work immediately.

Doug:

We have evaluated the cost of constructing the above referenced sewer repair as per your meeting with Bobby Coursey and myself. The work to be performed is as follows.

1. Set up three (3) each sewer bypass systems.
2. Remove and replace existing 15" sewer pipe with 16" pvc C-900 green pipe including all dewatering, coring and booting existing structures, trench safety, and testing.
3. Remove and replace existing cone and brick riser on W.W. and replace with new cone, riser, and grade rings.
4. Remove and replace existing roadway as necessary to facilitate construction including 100 lf overlay.

Total amount for above described work \$89,900.00

Recommend low BID

Please Note:

1. The existing manhole and wetwell which this work will concern are in disrepair causing concern as to their reaction with being uncovered. We have not included any repair or replacement for these structures.
2. Maintenance of traffic to be responsibility of Nasaau County Utilities.
3. Removal and/or relocation of existing utilities is not included.
4. Permits or fees are not included.
