

RESOLUTION 2005 - 84

A RESOLUTION AMENDING RESOLUTION 2005-76, WHICH ESTABLISHED AN EMERGENCY RELATING TO THE NASSAU AMELIA UTILITIES AND AUTHORIZED THE COUNTY ADMINISTRATOR TO ISSUE A NOTICE TO PROCEED TO COASTLINE UTILITY CONTRACTORS, INC.

WHEREAS, the Nassau Amelia Utilities ("NAU") Manager has advised the County Administrator of additional work that must be performed based upon the original emergency as set forth in Resolution 2005-76; and

WHEREAS, the Board of County Commissioners adopted Resolution 2005-76, which established an emergency related to Nassau Amelia Utilities ("NAU"); and

WHEREAS, the Board of County Commissioners authorized a Purchase Order in an amount up to \$90,000.00; and

WHEREAS, the NAU Manager has advised the County Administrator of an additional cost of \$5,846.96 that is necessary to address the work pursuant to the emergency; and

WHEREAS, the County Administrator concurs that the additional cost of \$5,846.96 is necessary and is part of the emergency previously declared in Resolution 2005-76; and

WHEREAS, the NAU Manager notified the County Administrator of the amount on May 4, 2005.

NOW, THEREFORE, BE IT RESOLVED this 11th day of May, 2005, by the Board of County Commissioners of Nassau County, Florida, that:


1. The Board of County Commissioners hereby amends Resolution 2005-76 to authorize an additional amount up to \$10,000.00.

2. The Board hereby authorizes the County Administrator to obtain a Purchase Order in the amount of \$5,846.96.

3. The Board hereby authorizes the County Administrator and the Manager of Nassau Amelia Utilities to notify Coastline Utility Contractors, Inc., of the approval of the amount of \$5,846.96.





Doug:

As you are aware we have incurred a 16" drop connection into the existing receiving manhole which is in disrepair due to sewer gas deterioration. As per your direction, we have initiated material orders to correct this deficiency. The materials will be delivered and the repair started tomorrow, May 10, 2005.

Cost for the removal and replacement of the 16" drop connection is as follows.

Material:

- 1. One (1) ea. 16" m.j. epoxy lined tee with accessories..... \$2,033.75
- 2. One (1) ea. 16" m.j. epoxy lined 90 degree bend with accessories..... \$1,597.21

Labor & Equipment

- 1. 8 hours labor \$1,282.00
- 2. 8 hours equipment \$1,642.00
- 3. 8 hours dewatering & by-pass \$ 792.00
- Total material, labor, and equipment.....\$7,346.96

Less credit for coring and booting manhole and pump station

- included in original pricing..... (\$1,500.00)
- Total Value For Above Work \$5,846.96
