

RESOLUTION 97 - 187


A RESOLUTION AMENDING ROAD CONSTRUCTION AND SUBDIVISION  
REGULATION REVIEW FEES PURSUANT TO ORDINANCE NO. 87-18 AS  
AMENDED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Nassau County, Florida, find that it is in the best interest of the citizens of Nassau County, Florida, that the fees paid for Development Approval fees to be amended.
