## ORDINANCE NO. 2002- <u>15</u> AMENDMENT TO ORDINANCE <u>91-04</u> NASSAU COUNTY, FLORIDA

WHEREAS, on the 28<sup>th</sup> day of January, 1991, the Board of County Commissioners, Nassau County, Florida, did adopt Ordinance No. 91-04, an Ordinance Enacting and Establishing the Comprehensive Land Use Map and the Future Land Use Map for the unincorporated portion of Nassau County, Florida; and

WHEREAS, the Board of County Commissioners seeks to reclassify land designation on the Land Use Map from Recreation to Medium Density Residential; and

WHEREAS, the Board of County Commissioners held a public hearing on April 22, 2002; and

WHEREAS, the property is located on the east side of Sabal Palm Drive between Elderberry Road and Sweet Gum Road in the Amelia Island area of Fernandina Beach, Florida; and

WHEREAS, the Board of County Commissioners finds that the amendment to the Future Land Use Map and reclassification is consistent with the overall Comprehensive Land Use Map and orderly development of Nassau County, Florida, and the specific area.

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Nassau County, Florida, this 22<sup>nd</sup> day of April 2002:

1. <u>SECTION 1. PROPERTY</u> <u>RECLASSIFIED</u>. The real property described in Section 2 is reclassified from Recreation to Medium

Density Residential with a limit of three (3) dwelling units per acre on the Future Land Use Map of Nassau County.

2. <u>SECTION 2. OWNER AND DESCRIPTION</u>. The land reclassified by this Ordinance is owned by Summer Woods of Nassau County, Ltd., and is described as follows:

See Exhibit "A" attached hereto and made a part hereof by specific reference.

3. <u>SECTION 3</u>. -Based -upon - the - agreed -upon - limitation - by - the -applicant - and - the -Board of - County - Commissioners of - Nassau - County, -Florida, -<u>T</u>this amendment is made a small-scale amendment pursuant to Florida Statutes, Section 163.3187.

4. <u>SECTION 4. EFFECTIVE DATE</u>. The effective date of this small-scale amendment shall be thirty-one days after adoption, unless the amendment is challenged pursuant to Section 163.3187(3), <u>Florida Statutes</u>. If challenged, the effective date of this amendment shall be the date a final order is issued by the Department of Community Affairs, or the Administration Commission, finding that the amendment is in compliance with Section 163.3184, Florida Statutes.
