ORDINANCE NO. 2012-31

AN ORDINANCE REPEALING ORDINANCE NO. 2007-07, WHICH ORDINANCE ESTABLISHED THE CHANDLER'S MEADOW COMMUNITY DEVELOPMENT DISTRICT; REPEALING THE ESTABLISHMENT OF SUCH DISTRICT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Nassau County established the Chandler's Meadow Community Development District (the "District") through the enactment of Ordinance 2007-07; and

WHEREAS, the District and Citizens State Bank, successor in title to Chandler Development I, LLC, have submitted a petition requesting that the Board of County Commissioners of Nassau County, Florida dissolve the District; and

WHEREAS, <u>Florida Statutes</u>, Section 190.046(9), provides that upon filing a petition by the District it may be dissolved by ordinance; and

WHEREAS, the Board of County Commissioners approved a Resolution vacating the plat of Chandler's Meadow prior to the consideration and adoption of this Ordinance; and

WHEREAS, The District has no outstanding financial obligations and no operating or maintenance responsibilities. No bonds were validated or issued in connection with the District; and

WHEREAS, the District has not taken title to any lands within its boundaries; and WHEREAS, the continued existence of the district serves no purpose.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida:

SECTION I. <u>DISSOLUTION</u>. At the request of Chandler's Meadow Community Development District and Citizens State Bank, successor in title to Chandler Development I, LLC, pursuant to the "Uniform Community Development District Act of 1980," Chapter 190, <u>Florida Statutes</u>, as set forth in the Petition to Dissolve the Chandler's Meadow Community Development District, the Chandler's Meadow Community Development District is hereby

dissolved, consistent with <u>Florida Statutes</u>, Section 190.046(9). The property set forth in the attached Exhibit "A" is no longer encumbered by the conditions of the Chandler's Meadow Community Development District.

SECTION II. EFFECTIVE DATE. This Ordinance shall take effect immediately.
