## **ORDINANCE NO. 2014- 23**

AN ORDINANCE AMENDING ORDINANCE NO. 2009-08, AS AMENDED, WHICH ESTABLISHED RENTAL RATES FOR THE USE OF NASSAU COUNTY FACILITIES AND BALL PARKS; SPECIFICALLY EXEMPTING GOVERNMENTAL AGENCIES FROM THE PROVISIONS FOR RENTAL OF COUNTY FACILITIES AND BALL PARKS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Nassau County, Florida, has adopted policies and procedures in place for the utilization of county facilities by the public; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, adopted Ordinance No. 2009-08 which sets forth the current rental rates for the use of Nassau County facilities; and

WHEREAS, the Board finds it necessary to supplement its policies in order to be fair and equitable to all citizens and organizations who wish to utilize the County's facilities; and

WHEREAS, the Board of County Commissioners finds that it is in the best interest of the citizens of Nassau County to include governmental agencies who desire to rent any county facility for the conduct of governmental agency business as being exempt from the rental rates for the use of Nassau County facilities.

NOW, THEREFORE, BE IT ORDAINED this 10th day of November, 2014, by the Board of County Commissioners of Nassau County, Florida, that Ordinance No. 2009-08, as amended, shall be further amended as follows:

- 1. The Board of County Commissioners approves the following fee schedule of rental amounts for the use of County facilities.
  - Rental Fee, Sales Tax, and Deposit Fees are to be collected from all renters, except those that are exempt pursuant to this Ordinance.that the Board of County Commissioners shall be permitted to grant waiver for bonafied not-for-profit agencies.

• Deposit minimum \$100.00 or 50% of the total rent (whichever is greater.)

- 2. The Board of County Commissioners further approves the Maintenance Department as the entity that addresses any conflicts between persons renting county facilities, and the Maintenance Department as the entity that addresses any conflicts between persons renting county facilities, and the Maintenance Department person in charge to determine if the facility is properly cleaned.
- 3. Bona-fide not for profit organizations must complete the necessary paperwork and obtain County Manager approval before renting a County Facility.
- 34. This ordinance shall not apply to the rental of county facilities by governmental agencies or county offices for the conduct of governmental or county business. In the

event county offices desire to rent any county facility for purposes other than county business, said rental fee shall be the same rate as set forth for non profit organizations.

- 4. Any organization or entity that is fee exempt or was quoted a price by county staff prior to the original adoption of April 13, 2009 shall remain exempt from the fee schedule until September 30, 2009.
- 5. Severability. If any section, sentence, clause or phrase of this Ordinance is held to be invalid or unconstitutional by any Court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions or this Ordinance.
- 6. Effective Date. This Ordinance shall become effective upon filing with the Department of State.
