ORDINANCE 2015 - 20

AN ORDINANCE OF NASSAU COUNTY, FLORIDA REZONING APPROXIMATELY 0.45 ACRE OF REAL PROPERTY LOCATED AT SOUTH SIDE OF SR200/A1A, BETWEEN I-95 AND SEMPER FI DRIVE, FROM COMMERCIAL HIGHWAY TOURIST (CHT) TO COMMERCIAL GENERAL (CG) PROVIDING FOR FINDINGS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Boswell Company is the owner of a portion of a parcel comprising 0.45 acre identified as Tax Parcel # 01-2N-26-0000-0003-0050 by virtue of Deed recorded at O.R. 383, page 22 of the Public Records of Nassau County, Florida; and

WHEREAS, Boswell Company has authorized Philip Griffin to file Application R15-009 to rezone the land described herein; and

WHEREAS, the Nassau County Planning and Zoning Board, after due notice conducted a public hearing on October 20, 2015 and voted to recommend approval of R15-009 to the Commission; and

WHEREAS, taking into consideration the above recommendations, the Commission finds that such rezoning is consistent with the 2030 Comprehensive Plan and the orderly development of Nassau County; and

WHEREAS, the proposed CG zoning complies with the underlying Future Land Use Map (FLUM) designation of Commercial; and

WHEREAS, the Board of County Commissioners held a public hearing on November 9, 2015; and

WHEREAS, public notice of all hearings has been provided in accordance with Chapters 125 Florida Statutes and the Nassau County Land Development Code.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1. FINDINGS.


That the proposed rezoning to Commercial General (CG) is generally consistent with the goals, objectives and policies of the 2030 Comprehensive Plan, in particular ED.05.02 and FL.08.05.

SECTION 2. PROPERTY REZONED.

The real property described in Section 3 is rezoned and reclassified to Commercial General (CG) upon the effective date of the ordinance, the Planning and Economic Opportunity Department is authorized to amend the Official Zoning Map to reflect this change.

SECTION 3. OWNER AND DESCRIPTION.

The land reclassified by this Ordinance is owned by Boswell Company and is identified by the following tax identification numbers, graphic illustration, and legal descriptions:

LEGAL DESCRIPTION

A portion of Section 39, together with a portion of Government Lot 1, Section 1, Township 2 North, Range 26 East, Massau County, Florida, being more particularly described as follows:

For Point of Reference commence at a concrete nonument at the intersection of the southerly right-of-way line of State Road No. 200 (a 160-foot right-of-way as now established) and the easterly right-of-way line of Johnson Lake Road (a 66-foot right-of-way as now established) and run North 72° 19' 01" East along said southerly right-of-way line, a distance of 214.63 feet to a point for the Point of Beginning, said point also being the beginning of the limited access right-of-way line of Interstate Highway No. 95.

From the Point of Beginning thus described run thence North 72° 19' 01° East, along said southerly limited access rightof-way line of Interstate Highway No. 95, a distance of 100.00 feet to an angle point in said limited access right-of-way; run thence South 89° 20' 54° East, continuing along said limited access right-of-way line of Interstate Highway No. 95, a distance of 167.32 feet to a point; run thence South 72° 19' 01° West, a distance of 212.11 feet to a point; run thence North 17° 16' 59° West, a distance of 125.00 feat to the Point of Beginning. The lands thus described contain 19,506 square feet or 0.45 acres, more or less.

SECTION 4. EFFECTIVE DATE.

This Ordinance shall be effective upon filing with the Secretary of State.
