AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, AMENDING ORDINANCE NO. 2017-30, WHICH AMENDED ORDINANCE NOS. 89-7, 90-3, AND 95-4, KNOWN AS THE **TRADEPLEX** PUD/DRI ORDINANCE, **SPECIFICALLY** ORDINANCE NO. 2017-30, TO CORRECT A SCRIVENER ERROR; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Nassau County, Florida, adopted Ordinance No. 2017-30 on September 25, 2017; and

WHEREAS, Ordinance No. 2017-30 further amended Ordinance No. 89-7, as amended, known as the Tradeplex PUD/DRI Ordinance;

WHEREAS, it has been determined that Ordinance No. 2017-30 contained a scrivener error in that Ordinance No. 2017-30 referenced that it amended Ordinance No. 90-05, but in fact the correct reference to the ordinance number being amended should have been Ordinance No. 90-03.

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Nassau County, Florida, as follows:

- 1. The references to Ordinance No. 90-05 in Ordinance No. 2017-30 are hereby corrected to reflect Ordinance No. 90-03.
- 2. All other provisions of Ordinance No. 2017-30 remain unchanged.

SEVERABILITY

It is the intent of the Board of County Commissioners of Nassau County, Florida and is hereby provided, that if any section, subsection, sentence, clause, phrase or provision of this Ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction, such invalidity or unconstitutionality shall not be so construed as to render invalid or unconstitutional the remaining provisions of this Ordinance. that the provisions of this Ordinance shall be included and incorporated into the Code of Ordinances of
