

ORDINANCE NO. 2018 - 27

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, AMENDING ORDINANCE NO. 2009-09, AS AMENDED, KNOWN AS THE PURCHASING POLICY FOR NASSAU COUNTY, FLORIDA; AMENDING SECTION 9, RESCINDING THE WAIVER AS TO COMPLIANCE WITH 2 CODE OF FEDERAL REGULATIONS (C.F.R.) PART 200.317 THROUGH 2 C.F.R. PART 200.326 AND REQUIRING COMPLIANCE; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Nassau County, Florida had waived compliance with 2 C.F.R. Part 200.317 through 2 C.F.R. Part 200.326; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida amends Ordinance No. 2009-09, as amended, to require compliance with 2 C.F.R. Part 200.317 through 2 C.F.R. Part 200.326.

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Nassau County, Florida:

1. The Nassau County Purchasing Policy is to be amended as follows:

SECTION 9. COMPLIANCE WITH 2 CODE OF FEDERAL REGULATION (C.F.R.) PART 200.317 THROUGH 2 C.F.R. PART 200.326.

- A. ~~Waiver. Compliance with 2 C.F.R. Part 200.326 is waived through September 30, 2018 and the County will continue to comply with procurement standards in previous OMB guidance through September 30, 2018~~ Nassau County, Florida shall comply with 2 C.F.R. Part 200.317 through 2 C.F.R. Part 200.326.
2. The Board of County Commissioners of Nassau County, Florida hereby delegates to the County Manager the authority to develop additional procurement procedures for Federal awards.
3. SEVERABILITY

If any portion of this ordinance is for any reason held or declared to be unconstitutional, inoperative or void, such holding shall not affect the remaining portions of this ordinance. If this ordinance or any provision thereof shall be held to be inapplicable to any person, property or


circumstances, such holding shall not affect its applicability to any other person, property or circumstances.

This Ordinance shall become effective upon its being filed with the Office of the Secretary of State.




