

**ORDINANCE NO. 2020-18**

**AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, AMENDING CHAPTER 8 ¾ OF THE NASSAU COUNTY CODE OF ORDINANCES (ORDINANCE NO. 2004-46), SPECIFICALLY SECTION 8¾-10 COURT SURCHARGES; PROVIDING SEVERABILITY; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Section 318.18(13)(a), Florida Statutes, authorizes the Board of County Commissioners to impose a surcharge of up to \$30.00 for noncriminal traffic infractions pursuant to Chapter 318 or criminal violations listed in Section 318.17, Florida Statutes, to fund State court facilities; and

**WHEREAS**, the Board of County Commissioners finds it to be in the best interest of the citizens of Nassau County to impose a \$30.00 surcharge pursuant to said statutory authority; and

**WHEREAS**, the Board of County Commissioners finds it necessary to amend Section 8¾-10 to increase the imposed surcharge amount from fifteen dollars (\$15.00) to thirty dollars (\$30.00); and

**WHEREAS**, the amending of Chapter 8¾ will promote the health, safety, and welfare of the citizens of Nassau County, Florida.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of County Commissioners of Nassau County, Florida, that Section 8¾-10, Court Surcharges, of the Nassau County Code of Ordinances, shall be amended to read as follows:

**SECTION 8¾-10 – COURT SURCHARGES**

- (a) [*Surcharge imposed.*] In addition to any penalties imposed for noncriminal traffic infractions pursuant to F.S. ch. 318 or imposed for criminal violations listed in F.S.

§318.17, there is hereby imposed a surcharge of ~~fifteen~~ thirty dollars (\$~~15~~30.00). The court shall not waive this surcharge.

(b) *Use of surcharge.* The revenue generated from the ~~fifteen~~ thirty-dollar (\$~~15~~30.00) surcharge shall be used to fund state court facilities.

(c) *Applicability.* The provisions of this ordinance [section] shall apply within the incorporated and unincorporated areas of Nassau County.

**SEVERABILITY.**



**EFFECTIVE DATE.**


This ordinance shall become effective upon its being filed in the office of the Secretary of State.


