

**ORDINANCE 2020 - 38**

**AN ORDINANCE OF NASSAU COUNTY, FLORIDA REZONING APPROXIMATELY 437.70 ACRES OF REAL PROPERTY LOCATED ON THE NORTH AND SOUTH SIDE OF WILLIAM BURGESS BOULEVARD, BETWEEN THE ROBERT M. FOSTER JUSTICE CENTER AND HARVESTER STREET, FROM OPEN RURAL (OR), COMMERCIAL JUDICIAL (CJ) AND RESIDENTIAL JUDICIAL (RJ) TO TRANSECT DISTRICTS DEFINED IN THE WILLIAM BURGESS DISTRICT CONTEXT AND CONNECTIVITY BLUEPRINT AS T-4 URBAN EDGE/URBAN GENERAL ZONE, T-3.5 URBAN TRANSITIONAL ZONE, T-3 SUB-URBAN ZONE, AND T-1 CONSERVATION ZONE; ADOPTING A UNIFIED DEVELOPMENT PLAN; PROVIDING FOR FINDINGS; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Cook Family Haverstick, LLC., Cook Family Vanzant LLC, Cook Family Burgess Faye Jones, LLC., and JMC Nassau County Properties, LLC are the owners of eight parcels comprising +/-437.70 acres identified as Tax Parcel #s 08-2N-27-0000-0002-0000(portion), 08-2N-27-0000-0007-0000, 17-2N-27-0000-0001-0000, 08-2N-27-0000-0003-0000, 45-2N-27-0000-0002-0000, 08-2N-27-0000-0003-007008-2N-27-0000-0003-0060, and 08-2N-27-0000-0004-0000, by virtue of Deed recorded at O.R.1776, page 1424, and O.R. 2022, pages 1450, 1459, and 1466 in the Public Records of Nassau County, Florida; and

**WHEREAS**, Cook Family Haverstick, LLC., Cook Family Vanzant LLC, Cook Family Burgess Faye Jones, LLC., and JMC Nassau County Properties, LLC have authorized Gregory E. Matovina to file Application R20-003 to rezone the land described herein; and

**WHEREAS**, the Nassau County Planning and Zoning Board, after due notice conducted a public hearing on March 3, 2020 and voted to recommend approval of R20-003 to the Commission; and

**WHEREAS**, taking into consideration the above recommendations, the Commission finds that such rezoning is consistent with the 2030 Comprehensive Plan and the orderly development of Nassau County; and

**WHEREAS**, the proposed Transect Districts defined in the William Burgess District Context And Connectivity Blueprint as T-4 Urban Edge/Urban General Zone, T-3.5 Urban Transitional Zone, T-3 Sub-Urban Zone, And T-1 Conservation Zone comply with the underlying Future Land Use Map (FLUM) designations of T-4 Urban Edge/Urban General Zone, T-3.5 Urban Transitional Zone, T-3 Sub-Urban Zone, And T-1 Conservation Zone; and

**WHEREAS**, the Board of County Commissioners held a public hearing on November 9, 2020; and

**WHEREAS**, public notice of all hearings has been provided in accordance with Chapters 125 Florida Statutes and the Nassau County Land Development Code.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, AS FOLLOWS:**

**SECTION 1. FINDINGS.**

The proposed rezoning is generally consistent with the goals, objectives and policies of the 2030 Comprehensive Plan, in particular Policies FL.01.02(I), FL.01.04, FL.02.05, FL.08.01 and CI.02.01.

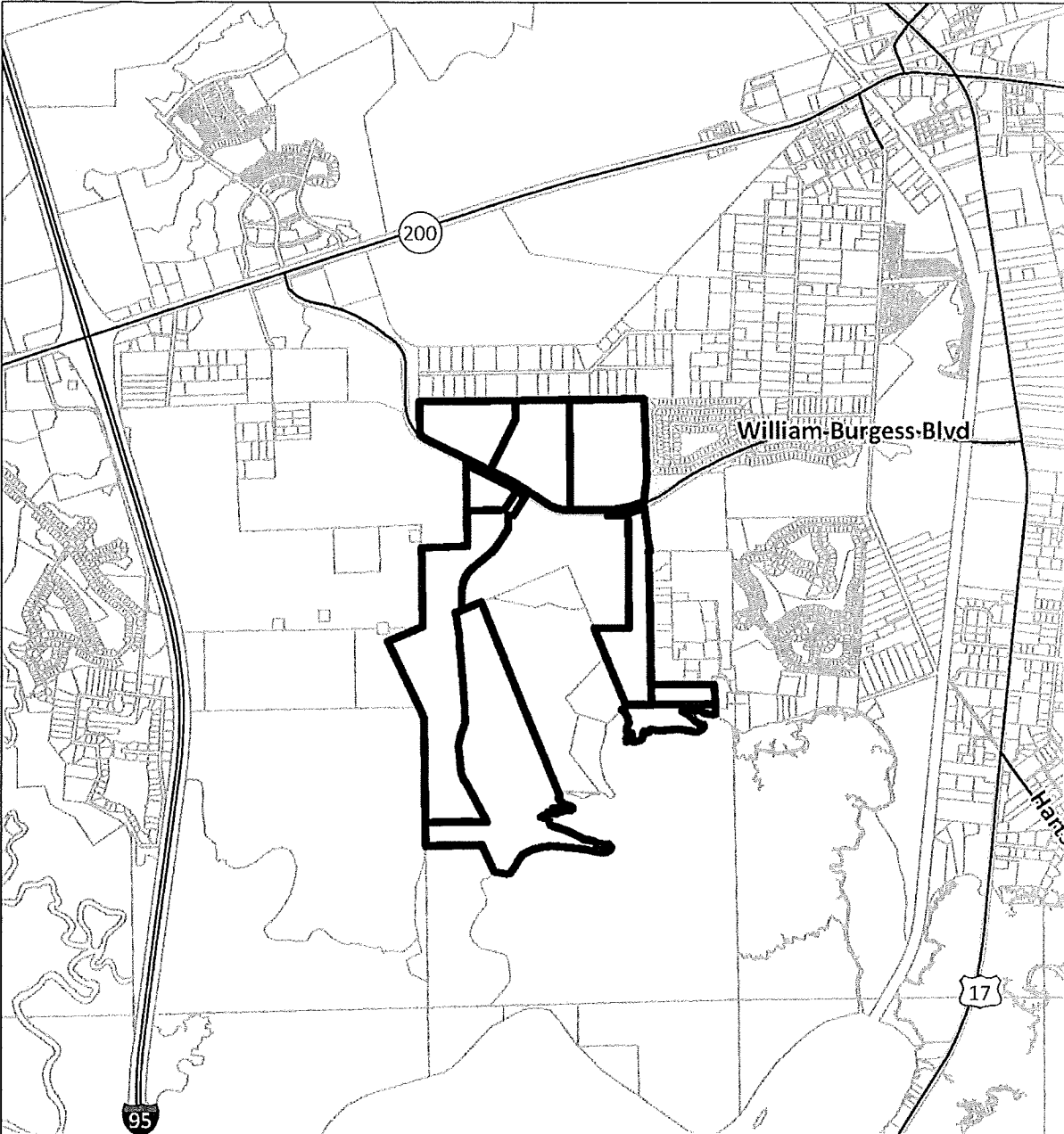
**SECTION 2. PROPERTY REZONED.**

- A. The real property described in Section 3 is rezoned and reclassified to Transect Districts defined in the William Burgess District Context And Connectivity Blueprint as T-4 Urban Edge/Urban General Zone, T-3.5 Urban Transitional Zone, T-3 Sub-Urban Zone, And T-1 Conservation Zone upon the effective date of the ordinance, the Planning and Economic Opportunity Department is authorized to amend the Official Zoning Map to reflect this change.
- B. The property is subject to the Unified Development Plan shown in Exhibit "A" attached herein. The Unified Development Program is the implementation mechanism for all development within the lands of the proposed amendment, including, but not limited to, the transportation network, reserved recreation lands, and reserved public school site. Substantial variations from this unified development program, including, but not limited to, relocation of roadway network or park lands shall require approval of the Board of County Commissioners.

**SECTION 3. OWNER AND DESCRIPTION.**

The land reclassified by this Ordinance is owned by Cook Family Haverstick, LLC., Cook Family Vanzant LLC, Cook Family Burgess Faye Jones, LLC., and JMC Nassau County Properties, LLC and is identified by the following tax identification numbers, graphic illustration, and transect map and legal descriptions included in Exhibit "B" attached herein.




**SECTION 4. EFFECTIVE DATE.**



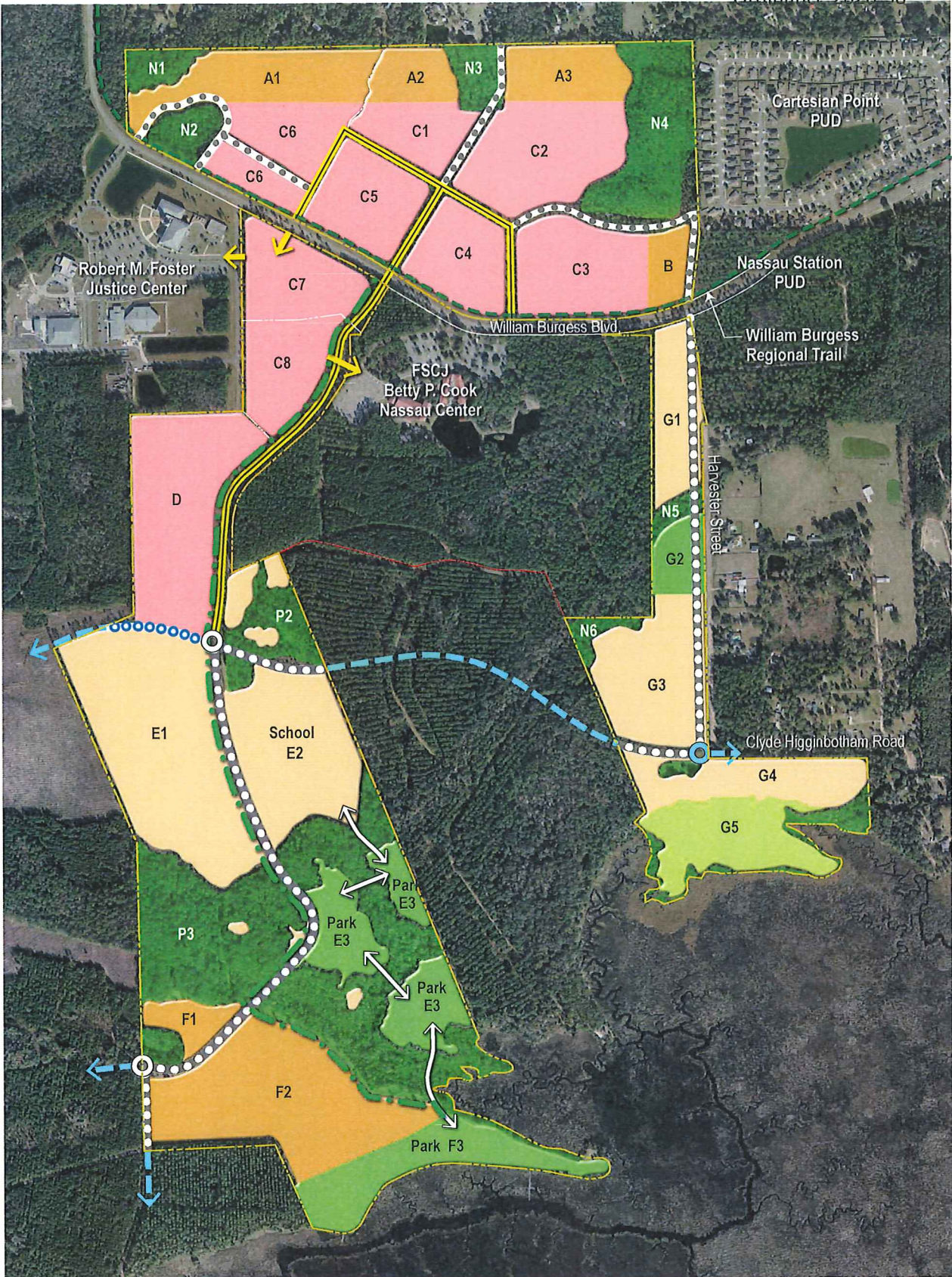

5. The maximum non-residential square footage within the T-4, Transect shall be limited by building height, floor area ratio (FAR) standards, and operational traffic limitations.

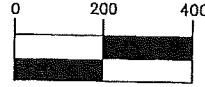

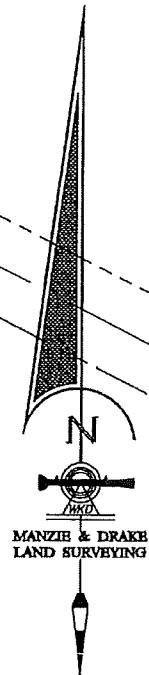

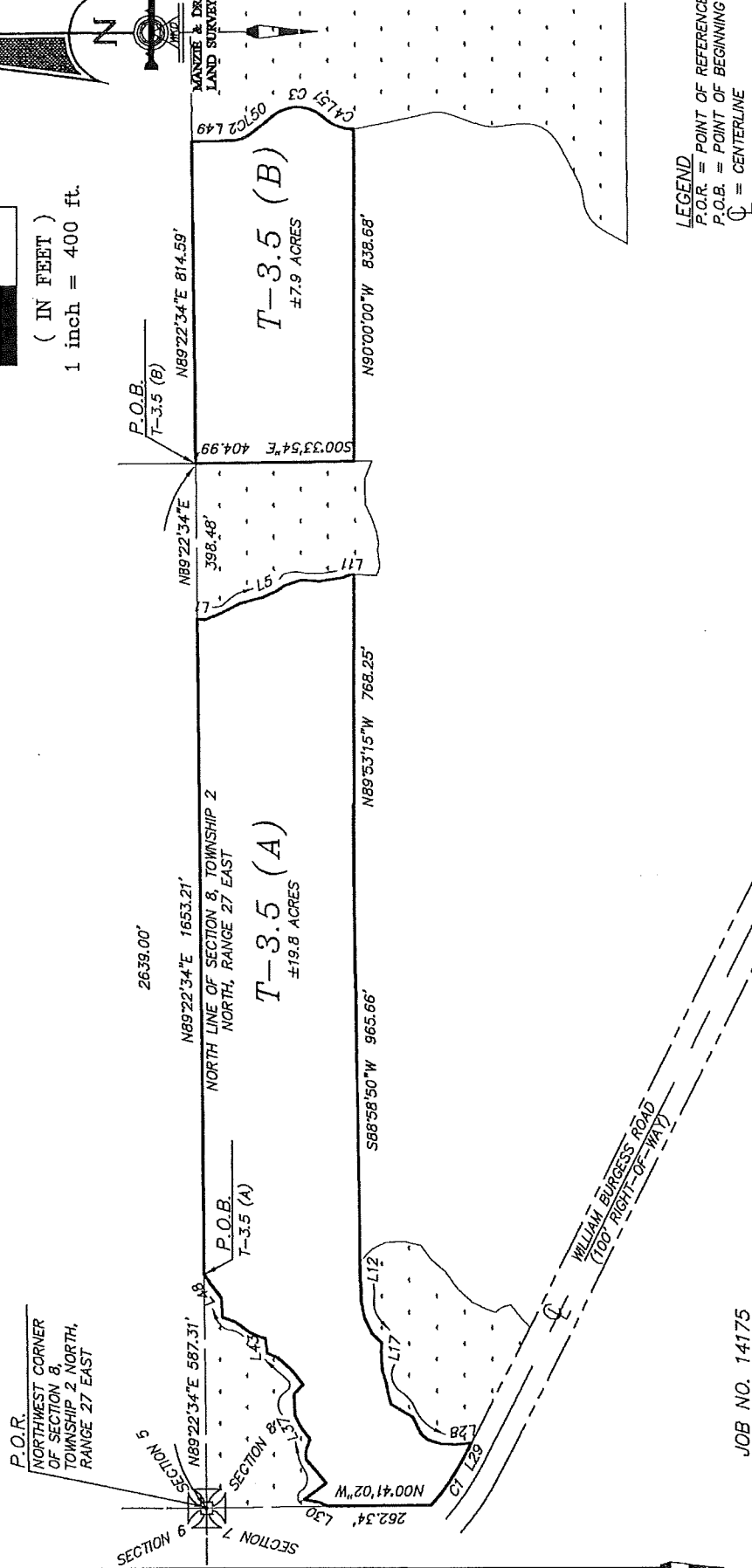

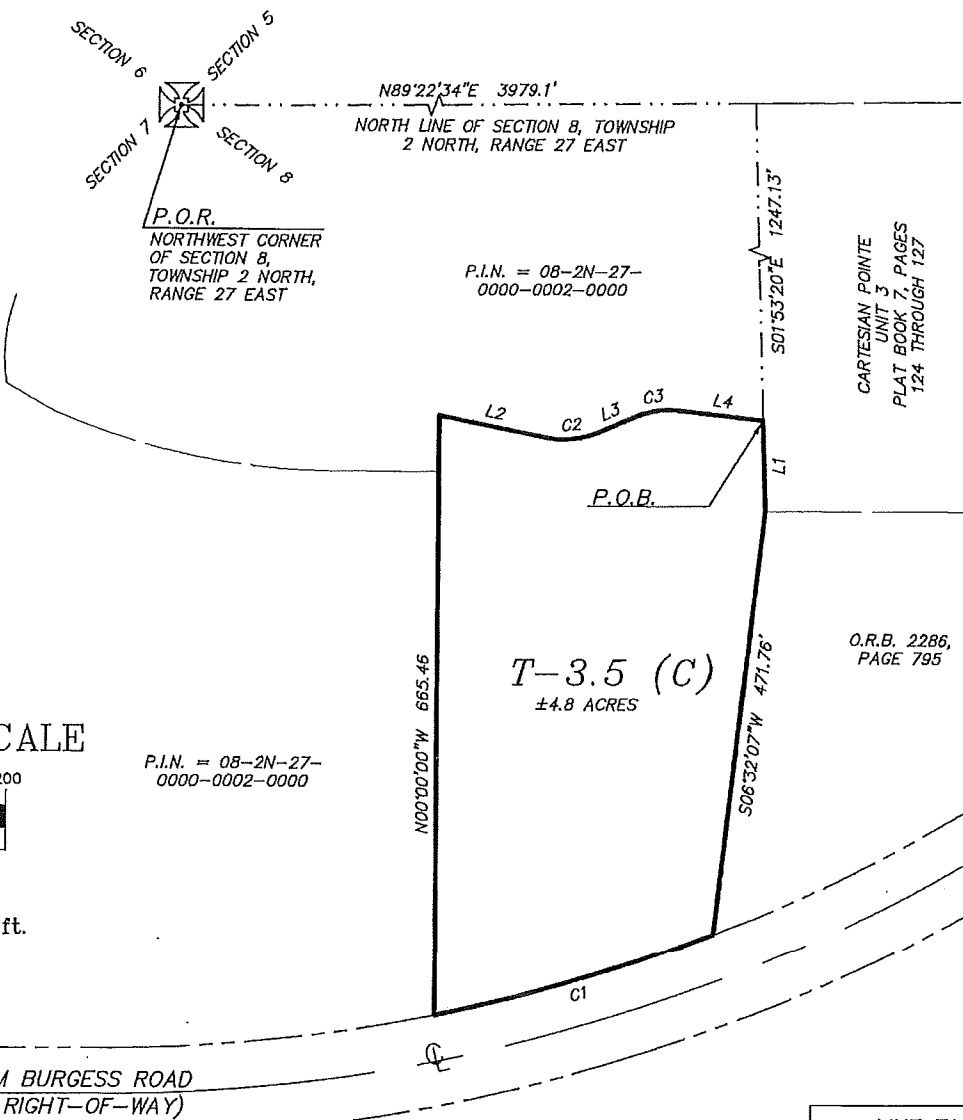
