

RESOLUTION RECOMMENDING THE ADOPTION
OF A REGULATION BY THE FLORIDA GAME
AND FRESH WATER FISH COMMISSION PRO-
HIBITING COMMERCIAL FISHING AND TRAPPING
IN NASSAU COUNTY, FLORIDA.

WHEREAS, KRAFT ATHLETIC CLUB and NORTHEAST FLORIDA
SPORTSMAN CLUB have gone on record as requesting the Florida Game
and Fresh Water Fish Commission to prohibit commercial fishing of
all kinds and types within the confines of Nassau County and to
prohibit all types and kinds of fresh water fish trapping within
Nassau County, and have requested this Board to approve the adoption
of a regulation by the Florida Game and Fresh Water Fish Commission
to accomplish these purposes, and

WHEREAS, this Board feels that a regulation should be adopted
by said Commission prohibiting commercial fishing in fresh waters of
Nassau County and prohibiting the trapping of fresh water fish in said
County, and

WHEREAS, this Board wishes to recommend to said Commission
that such a regulation be adopted.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF NASSAU COUNTY, FLORIDA, in regular meeting duly
assembled, that the Florida Game and Fresh Water Fish Commission, be,
and it is hereby, requested to adopt a regulation prohibiting all fresh
water commercial fishing and the trapping of fresh water fish within
the boundaries of Nassau County, Florida.
