

RESOLUTION CHANGING POLLING PLACE  
FOR PRECINCT NUMBERED 7 IN NASSAU  
COUNTY, FLORIDA.

WHEREAS, the polling place for Precinct Numbered 7 in Nassau County, Florida, for many years has been located in the gymnasium of the Yulee High School, and

WHEREAS, the use of said gymnasium for said polling place has caused the officials of said school much inconvenience and has not been entirely suitable to the election officials in the holding of elections in said precinct, and

WHEREAS, this Board has constructed a County building located on the Southerly side of State Road No. 200-A between State Road 5 (U. S. Highway 17), and State Road 200, which building has been constructed for the dual purpose of a County Health Building and a polling place for said Precinct Number 7, and

WHEREAS, this Board feels that it is to the best interest of the electors of said Precinct Number 7 of Nassau County, Florida, that the polling place for said precinct be established at said County building above described for the purpose of holding all future elections.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, in meeting duly assembled, that the polling place for Precinct Number 7 in Nassau County, Florida, be, and the same is hereby, designated and established in the County building constructed for the County Health Department and for a polling place located on the Southerly side of State Road 200-A between State Road 5 (U. S. Highway 17) and State Road 200 in the Village of Yulee, Nassau County, Florida, and that all future elections, special, primary and general, shall be held in said building.

BE IT FURTHER RESOLVED that the Clerk of this Board is hereby directed to publish for four (4) consecutive times in the Fernandina Beach News-Reader, a newspaper of general circulation in Nassau County, Florida, a notice substantially as follows:

NOTICE OF CHANGE OF POLLING PLACE FOR PRECINCT NUMBERED 7 IN THE VILLAGE OF YULEE, NASSAU COUNTY, FLORIDA.

Notice is hereby given that the Board of County Commissioners of Nassau County, Florida, has changed the polling place for Precinct Numbered 7 located in the Village of Yulee, Nassau County, Florida, and that said polling place has now been designated and established to be at the new County Building located on the Southerly side of State Road 200-A between State Road 5 (U. S. Highway 17) and State Road 200, in the Village of Yulee, Nassau County, Florida, and that all elections, special, primary and general, hereafter held in Nassau County in said Precinct Numbered 7, shall be held at said polling place in said County building.
