

RESOLUTION CHANGING POLLING PLACE
FOR PRECINCT NUMBERED 9 IN NASSAU
COUNTY, FLORIDA.

WHEREAS, the polling place for Precinct Numbered 9 in Nassau County, Florida, for many years has been located in the Town Hall of the Town of Hilliard, Nassau County, Florida, and

WHEREAS, the use of said Town Hall has caused the officials of said Town of Hilliard, much inconvenience and has not been entirely suitable to the election officials in the holding of elections in said Precinct, and

WHEREAS, this Board has determined that the new Recreation Building constructed by the Town of Hilliard, Florida, on Lots 1 through 8 in Block 60, according to the official map of said Town of Hilliard, would be a much more suitable place in which to hold elections in said Precinct Number 9, and

WHEREAS, this Board feels that it is to the best interest of the electors of said Precinct Number 9 in Nassau County, Florida, that the polling place for said Precinct be established at said Recreation Building for the purpose of holding all future elections.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, in regular meeting duly assembled, that the polling place for Precinct Number 9 in Nassau County, Florida, be, and the same is hereby designated and established in said Hilliard Recreation Building above mentioned and that all future elections, special, primary and general, shall be held in said building, for said Precinct Number 9,

BE IT FURTHER RESOLVED that the Clerk of this Board is hereby directed to publish for four (4) consecutive times in the Fernandina Beach News-Leader, a newspaper of general circulation in Nassau County, Florida, a notice substantially as follows:

Notice is hereby given that the Board of County Commissioners of Nassau County, Florida, has changed the polling place for Precinct Numbered 9 located in the Town of Hilliard, and said polling place has now been designated and established to be at the Hilliard Recreation Building located on Lots 1 through 8 in Block 60, according to the official map of the Town of Hilliard, which building is located on the Westerly side of Oxford Street, between 4th and 5th Streets in said Town of Hilliard, and that all elections, special, primary and general, hereafter held in Nassau County in said Precinct Numbered 9, shall be held at said polling place in said Hilliard Recreation Building.
