

R E S O L U T I O N

WHEREAS, Nassau County has been without rain for an extended period of time causing the woodlands to be extremely dry and subject to fire, and

WHEREAS, under such conditions wood fires are most devastating and destructive causing great damage to the forest and game life of the County, effecting all of the citizens, and

WHEREAS, it behoves everyone who uses the woodlands of the County either for business, hunting or other purposes to be extremely careful of setting fires either carelessly or on purpose, and

WHEREAS, It is the purpose of this resolution to urgently request our visitors as well as our local citizens to be extremely careful to guard against and prevent fires which may get out of hand and cause great destruction to our forest and game life.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, in special meeting duly assembled, that all visitors to and residents of Nassau County be urgently requested to refrain from starting any fires in the woodlands of Nassau County or at any place that might spread to woodlands and to exert every effort to prevent fires in Nassau County which would endanger the woodlands and game life of Nassau County.

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the local newspapers, the Times Union and Jacksonville Journal Newspaper of Jacksonville and to all radio and television stations in the Jacksonville area with the request that such news media give this request as much publicity as possible.
