RESOLUTION PROVIDING FOR THE FURNISHING OF FIRE PROTECTION BY THE CITY OF FERNANDINA BEACH, FLORIDA, OF THE ENTIRE AREA KNOWN AS AMELIA ISLAND AND PROVIDING FOR THE PAYMENT BY NASSAU COUNTY OF COMPENSATION FOR SUCH SERVICES.

WHEREAS, the 1967 Florida Legislature did enact House Bill 2799 authorizing Nassau County to enter into agreements with the various municipalities in Nassau County to provide fire protection to areas adjacent to but not within their municipal limits and to pay said municipalities for providing such fire protection, and,

WHEREAS, the City of Fernandina Beach has agreed to use its fire fighting equipment and personnel for the purpose of giving fire protection to all of that area in Nassau County known as Amelia Island outside of the municipal limits of the City of Fernandina Beach, Florida, and the Board of County Commissioners of Nassau County, Florida, has agreed to pay for such service on an annual basis of \$7,500.00 commencing October 1, 1967, said payment to be made in advance, said agreement to continue from year to year thereafter unless cancelled by written notice by either party at least 30 days prior to September 30th during any year that the agreement is in force, and,

WHEREAS, this Resolution shall constitute a valid and binding contract between the Board of County Commissioners of Nassau County, Florida, and the City Commission of the City of Fernandina Beach, Florida, when duly adopted and executed by each body as provided by law.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, in regular meeting duly assembled, that said agreement be, and the same is hereby entered into by and between the Board of County Commissioners of Nassau County, Florida, and the City Commission of the City of Fernandina Beach, Florida, as follows:

1. That the City of Fernandina Beach, at its own cost and expense, shall render fire protection to that area of Nassau County, Florida, known as Amelia Island outside of the limits of said City of Fernandina Beach, provided, however, that the Fire Chief of said City is authorized to withhold aid for reasonable cause within his discretion and that the City of Fernandina Beach, will not be responsible for failure to respond to any call for fire protection and further that said City of Fernandina Beach reserves the right to withdraw from an outside fire if it is needed within the City Limits.

2. That Nassau County, through its Board of County

Commissioners shall pay to the City of Fernandina Beach, the

annual sum of \$7,500.00, in advance, for said fire protection in

said area, covering that period of time commencing on October 1,

1967, and ending September 30th, 1968, and from year to year there
after as long as this agreement shall remain in force and effect.

- 3. That this Agreement may be cancelled by either the Board of County Commissioners of Nassau County, Florida, or the City Commission of the City of Fernandina Beach, Florida, at the end of any annual period covered hereunder by giving 30 days written notice of such cancellation at least 30 days prior to September 30th of any year in which this contract is in force and effect.
- 4. That upon the adoption of this resolution by the Board of County Commissioners of Nassau County, Florida, and the City Commission of the City of Fernandina Beach, Florida, the same shall constitute a legal and binding agreement, and contract between said Board of County Commissioners and said City Commission.
