Sayford, Appraiser for the State Road Department and Nassau County, whose testimony constituted the principle evidence on behalf of petitioners; research and briefing of law preparatory to trial of case on questions anticipated to arise at the trial; preparing Verdict to be used at trial; actual trial of case before Judge Marion W.
