RESOLUTION ESTABLISHING LOAD AND WEIGHT
LIMITS UPON COUNTY ROAD KNOWN AS BAILEY
ROAD.

WHEREAS, the Board of County Commissioners of Nassau County, Florida, is authorized to prescribe load and weight limits upon County roads under Section 317.821, Florida Statutes, and

WHEREAS, this Board has determined that the design and present state of deterioration of that certain road known as Bailey Road, said road running Southerly from State Road 200, as shown on Ocean Breeze Farms, according to recorded plat in Plat Book 2, Page 19, of the public records of Nassau County, Florida, requires that a load and weight limit be established for motor vehicles, trucks, trailers or semi-trailers, and other weight bearing vehicles for the reason that said road is liable to be damaged or destroyed by said motor vehicles, trucks, trailers or semi-trailers which weight in the aggregate (both vehicle and load) shall not exceed the weight of 24,000 pounds, and

WHEREAS, this Board has determined that the notice provided for in said Section 317.821, Florida Statutes, be given establishing said weight and load limits;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, in regular meeting duly assembled, that weight and load limits be, and they are hereby, designated and prescribed for motor vehicles, trucks, trailers, or semi-trailers, using said road known as Bailey Road, as described in the preamble hereof, of a gross weight not to exceed 24,000 pounds for any motor vehicle, trucks, trailer, semi-trailer, or other vehicles traveling upon said Bailey Road.

BE IT FURTHER RESOLVED that a notice shall be given prescribing and establishing said weight and load limits on said Bailey Road in substantially the following form, to-wit:

NOTICE OF WEIGHT AND LOAD LIMITS
ON BAILEY ROAD.

Notice is hereby given pursuant to Section 317.821, Florida Statutes, that weight and load limits for motor vehicles, trucks, trailers, semi-trailers, and other vehicles, is hereby prescribed and established at a weight not to exceed 24,000 pounds upon that certain road known as Bailey Road, as shown on Ocean Breeze Farms, according to plat thereof, recorded in Plat Book 2, Page 19, Public records of Nassau County, Florida.
