

RESOLUTION NO. 41  
RESOLUTION CALLING SPECIAL  
ELECTION FOR THE PURPOSE OF  
ELECTING COMMISSIONERS FOR  
THE AMELIA ISLAND MOSQUITO  
CONTROL DISTRICT.

WHEREAS, the Amelia Island Mosquito Control District was duly created under Chapter 390 of the Florida Statutes and now exists under the provisions of Chapter 388, Florida Statutes since the consolidation of the laws governing mosquito control adopted by the 1959 Florida Legislature as will appear from Chapter 59-195, Laws of Florida, and

WHEREAS, under said Chapter 388.101, Florida Statutes, Commissioners of Mosquito Control Districts are required to be elected at the general election every four years at a special election called for said purpose, and

WHEREAS, the present commissioners of the Amelia Island Mosquito Control District were elected in the year 1966 for a term of four years which will expire in accordance with law, thereby requiring an election to be held for said offices at the general election in 1970, and

WHEREAS, it is the purpose of this resolution to cause the Clerk of this Board to publish a notice in the Fernandina Beach News-Leader, a newspaper of general circulation in Nassau County, Florida, notifying all electors residing in said Mosquito Control District who are duly registered upon the registration books of Nassau County, Florida, and who are qualified to vote in said election, that said special election will be held in all precincts on Amelia Island on November 3, A. D. 1970, the date of the general election for said year.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, in special meeting duly assembled, that a special election will be held on the 3rd day of

November, A. D. 1970, for the purpose of electing three (3) commissioners for the Amelia Island Mosquito Control District, comprising Election Precincts Numbered One (1), Two (2), Three (3), Four (4) and Five (5), of Nassau County, Florida.

BE IT FURTHER RESOLVED that the Clerk of this Board shall cause to be published in the Fernandina Beach News-Leader, a newspaper of general circulation in Nassau County, Florida, a notice of said special election in substantially the following form, to-wit:

NOTICE IS HEREBY GIVEN THAT PURSUANT TO CHAPTER 388, FLORIDA STATUTES, A SPECIAL ELECTION WILL BE HELD ON THE 3RD DAY OF NOVEMBER, A. D. 1970, FOR THE PURPOSE OF ELECTING THREE (3) COMMISSIONERS OF THE AMELIA ISLAND MOSQUITO CONTROL DISTRICT COMPRISING ALL OF AMELIA ISLAND IN NASSAU COUNTY, FLORIDA, AND COMPOSED OF ALL OF ELECTION PRECINCTS ONE (1), TWO (2), THREE (3), FOUR (4) AND FIVE (5) OF NASSAU COUNTY, FLORIDA; THAT ONLY THOSE ELECTORS RESIDING IN SAID DISTRICT AND WHO ARE DULY REGISTERED UPON THE REGISTRATION BOOKS OF NASSAU COUNTY, FLORIDA, AND QUALIFIED TO VOTE IN SAID PRECINCTS WILL BE ELIGIBLE TO VOTE IN SAID SPECIAL ELECTION.
